QUESTIONS AND CLARIFICATIONS

1. Question – With respect to Section 1. Objective – page 2

Section 1. – It is the intention of the Township to augment the equipment currently owned by the Township and operated by the Public Works staff.

The equipment being sourced through this Request for Quotation will be used on the designated routes as they appear in the “Form of Quotation”.

2. Question – With reference to Section 6. Scope of Work – page 6

Section 6.1 - It is the intention of the Township to receive quotations for the supply and operation of one (1) each of the specified Tandem Axle combination Snow Plow – Sander unit and the Tandem Drive Motor Grader.

Proponents are invited to submit a quotation for either the Snow Plow – Sander, the Motor Grader or both within their submission as required on the “Form of Quotation”.

Section 6.11 – Deployment of the equipment will be dependent on the weather and roadway conditions, typically at the same time as that of the municipally owned and operated equipment and at the discretion of the Public Works Foreman or designate.

Section 6.18 – The successful Proponent(s) shall be able to respond to the required location with the specified equipment with in four (4) hours of notification to do so.
