1. September 30<sup>th</sup> - Ontario Delivers \$2.8 Billion COVID-19 Fall Preparedness Plan

- The Ontario government has developed a **\$2.8 billion COVID-19 fall preparedness plan** to ensure the province's health care, long-term care and education systems are prepared for the immediate challenges of the fall, including a second wave of COVID-19 and the upcoming flu season.
- [Keeping Ontarians Safe: Preparing for Future Waves of COVID-19](#) will enable the province to **quickly identify, prevent and respond to surges and waves of the virus** to protect the health and safety of all Ontarians.
- The Keeping Ontarians Safe plan focuses on **key areas** to rapidly identify and respond to COVID-19 outbreaks and surges, build health system capacity, and reinforce the province's health care workforce. These areas are:
  1. [Maintaining strong public health measures, including continued expansion of testing and case and contact management](#)
    - Ontario is investing **\$1.376 billion** to enhance and expand efforts to test, trace and isolate new cases of COVID-19.
    - [Up to 80 pharmacies in Ontario are currently offering free COVID-19 testing by appointment only.](#)
    - The province has also added over 1,700 staff to assist with case and contact management.
  2. [Implementing the largest flu immunization campaign in Ontario's history](#)
    - Ontario is investing nearly **\$70 million** to purchase and distribute flu vaccines to deliver a robust and expanded campaign this year.
    - In addition, Ontario is investing **\$26.5 million** to purchase and administer additional flu vaccine doses if required and

**\$2 million** to purchase additional antiviral medication to support outbreak management of influenza in institutions.

**3. Quickly identifying, managing and preventing COVID-19 outbreaks**

- Ontario is investing **\$30 million** to build on its efforts to rapidly identify and contain any COVID-19 outbreaks.

**4. Accelerating efforts to reduce health service backlogs**

- Ontario is investing **\$283.7 million** to assist the health system's ongoing efforts to reduce surgery backlogs by supporting extend hours for additional priority surgeries and diagnostic imaging.
- The government is also **adding 139 critical care beds and 1,349 hospital beds** in hospitals and alternate health facilities across the province to support more surgical procedures.

**5. Preparing for surges in COVID-19 cases**

- Ontario is investing **\$457.49 million** to ensure that the health system is prepared to respond to any waves or surges of COVID-19 without interrupting routine health services.
- This includes helping up to **850 alternate levels of care patients** access the proper care in a home or community setting to help add more capacity in hospitals; expanding digital health and virtual services; improving access to mental health and addictions services and supports with a **\$26.75 million** investment; and increasing home and community care service by **adding 484,000 nursing and therapy visits** and **1.4 million personal support worker hours**.

**6. Recruiting, retaining, training and supporting health care workers, while also continuing to engage families and caregivers**

- Ontario is investing a total of **\$52.5 million** to recruit, retain and support over **3,700 more frontline health care workers and caregivers** to ensure the health care system can meet any surge in demand, while continuing to provide safe and high-quality care to patients and long-term care residents.

**7. Supporting Long-Term Care Homes**

- To support the six key areas of focus of Ontario's COVID-19 fall preparedness plan, the province also released [COVID-19: Long-term care preparedness](#), a plan that includes nearly **\$540 million** in long-term care

investments to prepare long-term care homes for future waves of COVID-19.

### **8. Supporting Schools and Child Care Centres**

- Earlier this month, Ontario released a **\$1.3 billion plan** to [reopen schools safely](#) and provided **\$234.6 million** through the federal Safe Restart Agreement for [child care and early years settings](#), which complements existing provincial and federal investments to help keep children and families safe.
- For schools, this includes funding to hire **more teachers to keep class sizes small, funding to hire additional nurses to facilitate public health and preventative measures**, including screening, testing, tracing and mitigation strategies, and **funding to hire 1,300 custodians** to enhance cleaning in schools and buses.

### **2. Ontario Releases 2020-21 First Quarter Finances**

- The Ontario government is continuing to support the province's recovery from COVID-19 over the long-term while delivering on its commitment to transparency and accountability with the release of **2020-21 First Quarter Finances** and an update to **Ontario's Action Plan: Responding to COVID-19**.
- To protect the health and economic well-being of the people of Ontario, the **government continues to invest and budget for further contingencies in the fight against the COVID-19 outbreak**, including providing support to families, businesses, workers, municipalities, long-term care homes and those on the front-lines of the pandemic.
- These investments bring the government's **COVID-19 response action plan to a projected \$30 billion**, up from \$17 billion announced in Ontario's Action Plan: Responding to COVID-19 on March 25, 2020.
- Since announcing the first steps in the government's response to the global pandemic, the government is making additional investments in the fight against COVID-19, including:

- i. An **increase of \$4.4 billion** for a total of **\$7.7 billion** to provide **ongoing support for health care** to build hospital capacity, prevent and contain the spread of COVID-19 in long-term care homes, ramp up testing and purchase personal protective equipment and critical medical supplies.
  - ii. An **increase of \$7.3 billion** for a total of **\$11.0 billion** to **support people and jobs**, which supports investments in a temporary pandemic pay for more than 375,000 eligible frontline workers totaling over \$1.5 billion, \$4 billion in targeted funding to help municipal partners and transit agencies to continue to deliver critical services, and temporary immediate relief for residential, farm, small business, industrial and commercial electricity consumers.
- The government is now projecting a **deficit of \$38.5 billion in 2020-21**, which incorporates the most up to date economic information and additional supports for the pandemic recovery period and the safe restart framework.
  - Private-sector forecasts, on average, **project that Ontario's real GDP will decline by 6.6 per cent in 2020**, down significantly from when the March 2020 Economic and Fiscal Update was finalized.
  - Total revenue is projected to be \$150.6 billion in 2020-21, \$5.7 billion lower and program expenses are projected to be \$13.1 billion higher than forecast in the March 2020 Economic and Fiscal Update.
  - As Ontario gradually reopens, following the plan outlined in *A Framework to Reopen Our Province*, there have been **recent signs of economic recovery**.
    - i. In June and July, **Ontario's employment increased by 528,600 net jobs** and **the unemployment rate decreased to 11.3 per cent**.
    - ii. **Home resales in the province rose 56.6 per cent in May and 67.0 per cent in June**, after declining for two consecutive months.
    - iii. **Ontario manufacturing sales increased 17.5 per cent in May**, while **retail sales rose 14.2 per cent**, after both declined for two consecutive months.
  - The Province's next fiscal update will be a multi-year provincial Budget, to be delivered no later than **November 15, 2020**.
  - Ontario was the first in Canada to release a fiscal outlook that reflected the impacts of the COVID-19 crisis.

**3. August 12<sup>th</sup> - Ontario Provides Update to Ontario's Action Plan: Responding to COVID-19**

- Since announcing the first steps in the government's response to the global pandemic on March 25, 2020, the government has made additional investments and budgeted for further contingencies in the fight against COVID-19.
- This includes allocating more support for people, jobs, a safe reopening, and the prevention of - or response to - a second wave.
- With these investments, the government's COVID-19 response action plan is now a projected **\$30.0 billion**, up from \$17 billion announced in Ontario's Action Plan: Responding to COVID-19 on March 25, 2020.

Supporting Health Care

- Since releasing the Action Plan, the government has committed even more resources to bolster health care and support frontline workers. Key investments and initiatives include:
  - i. Funding of **\$610 million** for the purchase of personal protective equipment and other critical supplies;
  - ii. **\$53 million** to ensure vulnerable people continue to have access to prescription medication during the pandemic;
  - iii. **\$50 million** to the Ontario Together Fund to help businesses provide innovative solutions or retool their operations to manufacture essential medical supplies and equipment to help stop the spread of COVID-19;
  - iv. **\$15 million** to support the design and implementation of the new Ontario Health Data Platform. This data platform provides recognized researchers and health system partners with access to anonymized health data that will allow them to better detect, plan and respond to COVID-19;
  - v. **\$15 million** in provincial support for 110 municipalities across the province towards the enhanced cleaning of transit systems;
  - vi. **\$14 million** in funding to provide additional community-based mental health and addictions services for people in Ontario with mental health needs;
  - vii. **\$12 million** to provide virtual mental health supports, including services to support frontline health care workers; and

- viii. To ensure that the resources are in place to support the health of the people of Ontario, the COVID-19 Health Contingency Fund has been increased by **\$4.3 billion**.

Supporting People and Jobs

- o Since releasing the Action Plan, the government has committed even more resources to support people and protect jobs through the crisis and in the long term. Key new investments and initiatives include:
  - i. Up to **\$4 billion** for municipalities and transit systems to provide one-time assistance, in partnership with the federal government, to help local governments address budget shortfalls related to COVID-19 and maintain the critical services people rely on every day;
  - ii. An investment of over **\$1.5 billion**, together with the federal government, providing a temporary pay increase of \$4 per hour for more than 375,000 eligible workers for work performed from April 24, 2020 to August 13, 2020.
  - iii. **\$340 million** to provide temporary immediate relief for industrial and commercial electricity consumers that do not participate in the Regulated Price Plan by deferring a portion of Global Adjustment charges, which is expected to be recovered over a 12-month period beginning in January 2021;
  - iv. **\$241 million** in funding committed by Ontario to partner with the federal government in order to provide over \$900 million in urgent relief to small businesses and their landlords through a new program, Canada Emergency Commercial Rent Assistance;
  - v. An increase of \$56 million for a total of **\$176 million**, to provide to May 31, 2020 the off-peak price of electricity for 24 hours a day for residential, farm and small business time-of-use customers;
  - vi. **\$50 million** to increase the government's contribution to the Risk Management Program for a total contribution of \$150 million annually. This funding supports farmers with unforeseen challenges such as fluctuations in market prices or production costs;
  - vii. **\$25 million** to ensure Ontario's food supply chain remains strong and ready to recover, including up to \$15 million to enhance health and safety measures on farms and in food processing facilities, and up to \$10 million in emergency assistance for beef and hog farmers;

- viii. **\$10 million** to provide financial support for Indigenous small- and medium-sized enterprises experiencing reduced or no revenue due to COVID-19;
- ix. **\$10 million** for the Connecting Links program, for a total investment of **\$40 million** in 2020-21, to support municipalities by helping them build, repair or replace municipal roads and bridges that connect two ends of a provincial highway through a community or to a border crossing;
  - **\$8 million** for the COVID-19 Energy Assistance Program for Small Business (CEAP-SB) to provide support to businesses struggling with bill payments as a result of the outbreak;
  - **\$8 million** to help small businesses reach more customers through the Digital Main Street platform. This program, in partnership with the federal government, will help up to 22,900 Ontario businesses create and enhance their online presence and generate jobs for more than 1,400 students;
  - **\$5 million** to support food rescue organizations to purchase critical infrastructure to ensure food is safely redistributed to those in need and help prevent nutritious food from ending up in landfills;
  - The Support for People and Jobs Fund has been increased by **\$3 billion** to ensure that Ontario has the resources to continue responding to the needs of the people of Ontario through the economic reopening and recovery phases; and
  - The standard Contingency Fund has been increased by **\$2.2 billion** to protect the health and safety of the people of Ontario during the COVID-19 outbreak.

4. October 16<sup>th</sup> - Ontario Supports the Production of Critical Supplies to Fight the Spread of COVID-19
- The Ontario government continues to work together with businesses and the manufacturing sector to expand production of domestic PPE to ensure preparedness, both now and for the future.
  - To support the fight against COVID-19, **Greenfield Global is investing a total of \$75 million at their facility in Johnstown Ontario** to produce the **medical-grade alcohol** critical to making hand sanitizers used by Ontario individuals, families, and front-line workers.
  - The Ontario government is investing **\$2.5 million** through the **Ontario Together Fund** in support of this project.
    - The government launched the \$50 million Ontario Together Fund to help businesses retool their operations to produce PPE and develop technology-driven solutions and services for businesses to reopen safely.
  - The project will help reduce Ontario's dependency on other jurisdictions as a source of high-grade alcohols and will strengthen the province's position as a leader in PPE production, while creating new jobs.
5. October 16<sup>th</sup> - Ontario Supports Innovation and Job Creation in the Life Sciences Sector
- The Ontario government welcomes the decision by **Roche** to invest **\$500 million over five years to establish a Global Pharma Technical Operations site** to oversee its global supply chain in Mississauga.
  - This investment is expected to create **500 jobs** — 200 by the end of 2020 and up to 300 more by the end of 2023. It will enhance Ontario's competitiveness and leadership in the life sciences sector.
  - The Global Pharma Technical Operations site will be responsible for supporting Hoffmann-La Roche Limited's global manufacturing and supply chain operations, including monitoring safety, quality and distribution of pharmaceutical products shipped around the world.
  - In 2012, Roche Canada established Mississauga as a Product Development Site, overseeing clinical trials both in Canada and globally.

- The success of this site, along with Ontario's highly skilled science, technology, engineering and mathematics (STEM) workforce, world-class colleges and universities and competitive business environment, saw the **province win out over 12 international locations and Roche sites** to secure this new investment, while positioning the province for future opportunities.
    - Through the **Better for People, Smarter for Business Act**, the government **is further reducing regulatory burdens** and encouraging investment in the life sciences sector by **allowing businesses to write off in-year capital costs on new equipment** and delivering on the government's commitment to **cut corporate income taxes through the \$3.8 billion Ontario Job Creation Investment Incentive**.
- 6. October 13<sup>th</sup> - Governments Investing \$26.6 Million to Further Protect Ontario Agri-Food Workers During COVID-19**
- The governments of Canada and Ontario are taking additional steps to **help farmers better protect the health and safety of agri-food workers in the province** during the COVID-19 outbreak to ensure the continued supply of locally grown food all year round.
  - A new agreement between Ontario and the federal government will see Agriculture and Agri-Food Canada invest an additional **\$11.6 million** to help support efforts by Ontario producers to stop the spread of COVID-19 on their farms.
  - Actions such as building physical barriers for worker separation, upgrading HVAC systems and enhancing hand-washing facilities will be eligible for this funding.
  - The federal funding that will be delivered by Ontario is in addition to the Ontario government's commitment in June of up to \$15 million to support workplace safety enhancements in the sector through the [Enhanced Agri-food Workplace Protection Program](#).
  - Under the expanded program, the amount farmers can claim for preventive expenses including a combination of workplace modifications, PPE, transportation and temporary housing will double to \$15,000.
  - The program will also include a new category for small capital projects of up to \$100,000 for housing modifications, workplace modifications and equipment to allow greater physical distancing for workers.

7. October 13<sup>th</sup> - Ontario Continues to Support Restaurants During COVID-19 Pandemic

- The Ontario government is encouraging everyone to support local restaurants and the food services industry during COVID-19.
- To **provide relief for local restaurants and other businesses** impacted by new public health measures, Ontario announced **\$300 million** to help **offset fixed costs, including property taxes, hydro and natural gas bills**.
- The government is also supporting small business through its [Main Street Recovery Plan](#) by:
  - Committing to permanently allow licensed restaurants and bars to include alcohol with food as part of a takeout or delivery order before the existing regulation expires;
  - Permanently allowing 24/7 deliveries to restaurants;
  - Supporting the distribution of local food and food products by increasing the range of products sold at the Ontario Food Terminal;
  - Ending outdated and duplicative rules so businesses can focus on their work;
  - Modernizing regulations to allow businesses to innovate and meet the challenges of today;
  - Providing mental health supports to business owners and employees who are struggling;
  - Providing \$57 million with federal partners through the Digital Main Street program and creating new Digital Main Street squads to help small businesses grow online; and
  - Launching a new portal to assist small businesses to quickly find the supports and information they need.

8. October 13<sup>th</sup> - Ontario Helps Keep Energy Costs Low for Families, Small Businesses and Farmers
- The Ontario government is helping to **keep the cost of energy low for families, small businesses and farmers** by **keeping electricity rates stable** and providing customers with more choice and energy assistance programs.
  - Customers eligible for the [Ontario Electricity Rebate \(OER\)](#) will automatically receive a **33.2% reduction off their energy bill** when [new electricity rates](#) for Regulated Price Plan (RPP) customers come into effect **November 1, 2020**.
  - At the same time, customers paying Time-of-Use (TOU) rates under the RPP will also have the option to switch to tiered rate pricing.
    - Time-of-use electricity rates vary by time of day and are comprised of three different rate periods of off-peak, mid-peak and on-peak pricing.
    - Tiered electricity rates provide customers with a set rate for electricity up to a certain level of consumption.
  - The province has also revised the eligibility requirements for the **COVID-19 Energy Assistance Program (CEAP) and the COVID-19 Energy Assistance Program for Small Business (CEAP-SB)**.
    - Households, small businesses and charitable organizations who made partial payments on amounts owing before the COVID-19 emergency period are now eligible for the CEAP and CEAP-SB one-time on-bill credit to help pay down electricity bill debt.
  - Ontario is also introducing a new streamlined **Energy Affordability Program (EAP)** for households struggling to pay their electricity bills. Beginning the week of **January 4, 2021**, EAP will:
    - Provide free electricity saving measures to help participating households manage their electricity-use and lower their electricity costs by up to \$1,000 per year;
    - Tailor energy-efficiency upgrades based on household income, home heating system, location, and an energy needs assessment; and,
    - Simplify access to new and updated electricity saving measures through a single program that replaces the Affordability Fund Trust and Home Assistance Program, which are ending in 2020.

- The **Energy Affordability Program** is part of Ontario's new **2021-2024 electricity Conservation Demand Management (CDM)** Framework, which also offers energy-efficiency programs for on-reserve First Nations consumers and Ontario business and industrial consumers to increase competitiveness and lower electricity costs.
  - The new Framework will come into force **January 1, 2021**, immediately following the end of the current Interim Framework on December 31, 2020.

**9. October 13<sup>th</sup> - Ontario Increases Production of COVID-19 Testing Supplies**

- The Ontario government is investing over **\$1.4 million in Mississauga-based Microbix Biosystems to expand production of COVID-19 testing supplies** and further support the province in the ongoing fight against COVID-19.
- With Ontario's support, Microbix will make viral transport media, which is the solution used to preserve and transport a patient's test specimen.
- This viral transport media will be used in COVID-19 patient sampling kits to support the province's urgent need for testing supplies and reduce the pressure on labs to assess variable international sources while also processing thousands of tests daily.
- Through the **Ontario Together Fund**, the government is delivering targeted investments that will increase the province's stockpile of Ontario-made products and PPE.

**10. October 9<sup>th</sup> - Ontario Adding and Expanding Highway Rest Areas in the North**

- The Ontario government is **improving travel for drivers in Northern Ontario by building four new rest areas and repairing or expanding 10 existing facilities along provincial highways**.
- The new amenities will include more bathrooms, improved lighting and increased parking.
- This is part of the government's plan to connect communities, build safer and better highways, help combat human trafficking, and **keep our supply chain strong** in every part of the province.
- For the 2020-21 fiscal year, Ontario is investing **\$2.6 billion** to repair and expand provincial highways and bridges, including construction funding of \$625 million in northern Ontario.
- These smart investments are estimated to create or sustain approximately **15,830 direct and indirect jobs** and improve quality of life for workers, families and small businesses across Ontario.
- Ontario 511 and the 511 app, with its easy to use map view and drive mode, will be updated whenever a rest area is expanded or developed to identify new facilities for truckers.

**12. October 8<sup>th</sup> - Historic Ford Canada Investment Transforming Ontario into Global Electric Vehicle Manufacturing Hub**

- The Ontario government is matching a **\$295 million** investment with the federal government to retool **Ford of Canada's Oakville Assembly Complex** into a **global hub for battery electric vehicle production**.
- This **\$1.8 billion** investment represents one of the **most significant investments in the province's auto sector** in a generation.
- Ford's Oakville plant directly employs over **3,000 people** and will be modernized with a flexible manufacturing system able to accommodate multiple battery electric vehicle (BEV) models.
  - It will also include the installation of a battery-pack assembly line.
  - The Oakville Assembly Complex will become **one of Ford's highest volume BEV plants in North America**, with the first electric vehicles expected to roll off the production line in 2025.
- In addition to securing the future of the Oakville Assembly Complex, this investment is a major win for the auto parts industry in Ontario and its **63,000 workers** who help build parts and components for vehicles assembled in the province and abroad.
- Ontario is the only place in North America where five major automakers build vehicles — Fiat Chrysler, Ford, General Motors, Honda and Toyota — as well as truck manufacturer Hino.
- Ontario is also home to more than **250 companies** and organizations active in the development of connected and **autonomous vehicle technologies**.
  - This expertise is woven together by Ontario's [Autonomous Vehicle Innovation Network \(AVIN\)](#).

**13. October 7<sup>th</sup> – Ontario Supports Small Main Street Businesses with \$60 Million in Funding through PPE Grant**

- The Ontario government is continuing to help businesses rebuild, reinvest and create good jobs across the province.
- The Provincial government has announced **Ontario's Main Street Recovery Plan** and intends to introduce the **Main Street Recovery Act, 2020**, proposed legislation that would **support small businesses and modernize rules** to allow them to innovate and meet the challenges of today.

  - Ontario's **Small Business COVID-19 Recovery Network**, which links 47 Small Business Enterprise Centres across the province as places where small businesses can access tailored advice and information on local, provincial and federal programs;
  - **Digital Main Street Squads** to help small businesses grow online;
  - **Mental health supports** for families, frontline workers, young people, children, and Indigenous communities;
  - **Ontario's Small Business Recovery Webpage** to provide single window access to small business supports.
- o The plan's **regulatory and legislative changes, if passed**, will:
  - Commit to exploring options to permanently **allow licensed restaurants and bars to include alcohol** with food as part of a **takeout or delivery** order before the existing regulation expires;
  - Permanently allow **24/7 deliveries to businesses** that include retail stores, restaurants, and distribution facilities;
  - Support the **distribution of local food and food products** by increasing the range of products sold at the Ontario Food Terminal;
  - Enable **Community Net Metering** demonstration projects to help support local communities to develop innovative community projects like net-zero or community micro-grids;
  - Modernize the **Assistive Devices Program**;
  - Support **Ontario's Taxi and Limousine Industry** by increasing fines for illegal operators.
- o Ontario is helping businesses overcome the unique challenges created by this pandemic with **50 temporary regulatory changes** made to help them adapt and about 400 more roadblocks being explored.

**14. October 7<sup>th</sup> - Ontario Supporting Scientists Developing the Next Generation of Antibiotics**

- The Ontario government is investing **\$1 million** to support the **creation of a Canadian Compound Library for Antibiotic Discovery at McMaster University**.
- This investment will help researchers discover and develop the next generation of antibiotics to help combat antibiotic resistance.
  - Antibiotic resistance means that a growing number of infections, such as pneumonia, tuberculosis and food-borne illnesses, are becoming harder to treat as the antibiotics used to treat them become less effective.
- The research being undertaken will identify a set of rules and guidelines that can be adopted by **researchers and the private sector** to accelerate antibiotic drug discovery and development, create an antimicrobial chemical library and develop and disseminate online education modules to provide timely information on antibiotic advancements to the public, researchers and clinicians.

- The Ontario government continues to deliver on its commitment to **remove regulatory roadblocks, cut red tape and support job creation** with the introduction of the **Better for People, Smarter for Business Act, 2020**.
- The legislation is part of the province's made-in-Ontario plan for growth, renewal and economic recovery.
- If passed, the act will strengthen Ontario's economic recovery, support businesses on the ground, and help government deliver clear and effective rules that promote public health and safeguard the environment without sacrificing innovation, growth and opportunity.
- The **proposed changes** in the act, along with other measures, include:
  - i. Requiring gas and electric utilities to adopt the Green Button Connect My Data and Download My Data standard to help Ontarians understand their energy use and reduce costs;
  - ii. Supporting renewable and alternative fuels and emissions reduction technology;
  - iii. Allowing single traffic studies for an entire specified highway corridor or area to reduce duplication and enable developers to get shovels in the ground faster;
  - iv. Protecting the environment and the health and safety of Ontarians by improving hazardous waste tracking;
  - v. Consulting on amendments to clarify when pre-start reviews are required in factories in order to make it easier for businesses to comply;
  - vi. Making it easier for property developers to get the environmental information they need by moving from a manual paper-based

**17. October 2<sup>nd</sup> - Canada and Ontario Strengthening Farmers and Food Supply Through Skilled Trades Training**

- The governments of Canada and Ontario today announced they are investing in several projects that will **support labour and training needs in the farming sector**, including committing more than **\$180,000** for the development of a **new college program** that will provide education and training in the **latest agricultural equipment**.
- The federal and provincial governments will assist **Conestoga College** in the creation, launch and delivery of a pilot program to expand the training opportunities for current farm sector employees and better prepare those interested in careers in agriculture to work on farms in key areas.
- Through a targeted intake under the **Partnership's Place to Grow: Agri-Food Innovation Initiative**, the governments have also recently committed up to **\$594,000** to projects to boost labour supply and training in the agri-food sector.

**20. September 28<sup>th</sup> - Ontario Launches Recovery Program for Northern Businesses Impacted by COVID-19: Applications open October 1, 2020**

- The Ontario government has announced the creation of a **new short-term Northern Ontario Recovery Program (NORP) to help businesses adapt to new COVID-19 public health guidelines and protect employees and customers.**
- Companies can apply to NORP for assistance with projects that help them adjust to the impacts of COVID-19, such as, but not limited to:
  - i. Building renovations and new constructions
  - ii. Customer and employee safety installations
  - iii. Equipment purchases, including personal protective equipment (PPE)
  - iv. Marketing for new business initiatives

- Oxford Pallet is the first company to be approved for funding under the [Forest Sector Investment and Innovation Program](#), a program designed to help Ontario forestry companies develop and implement innovative technology.
- The investment will create **20 new jobs**, double the plant's production capacity, **and increase lumber purchases from regional sawmills and lumber wholesalers in Ontario by more than 30 per cent.**
- The innovative equipment and technology planned in the company's expansion is a first of its kind in North America's pallet industry.
- Ontario's forest industry generates over \$18 billion in revenue and supports approximately 147,000 direct and indirect jobs in regions with few other industries.

**24. September 23<sup>rd</sup> - Ontario Partners with Scarborough-Based Auto Parts Manufacturers**

- The Ontario government **is investing in new technology adoption with two local auto parts manufacturers** in Scarborough to help improve efficiency, productivity and build capacity in the province's world-class automotive supply chain while creating and protecting jobs.
- Today the Provincial government announced that an investment of more than **\$175,000** from the [Ontario Automotive Modernization Program \(O-AMP\)](#) will be matched 1:1 by the recipient companies for these projects:
  - [Innotech Precision Inc.](#) — provides tooling, engineering and injection-molded components for the auto industry. The company is receiving \$98,582 towards real-time automated monitoring systems, which includes vision and production data analytics technology.

  - O-AMP supports manufacturing technology adoption and/or adoption of lean manufacturing processes. Funding covers up to 50 per cent of eligible project costs up to \$100,000, with recipient companies contributing the remainder through their own resources.
  - The current intake for O-AMP applications is open until **October 7th, 2020**.

**25. September 22<sup>nd</sup> - Ontario Investing to Support Francophone Businesses and Recovery**

- The Ontario government is pleased to announce a **new investment of \$500,000 to support Franco-Ontarian entrepreneurs and businesses**.
- \$250,000 will support the creation of a new online platform — the Francophone Business Network — that will help businesses share their expertise and best practices and form new strategic partnerships. The remaining \$250,000 will fund a campaign focused on promoting Franco-Ontarians products and services.
  - To set up the Network, the government will issue today a call for proposals targeting francophone organizations known for their expertise and reach out to the francophone business sector in Ontario.

**26. September 18<sup>th</sup> - Ontario Supporting Jobs and Economic Growth in Rural Communities**

- The Ontario government is committing nearly **\$1 million** in cost-share funding to **help rural communities diversify their economies, retain skilled workers and create jobs**.

  - ii. This temporary ban would continue to apply to businesses that are eligible for federal-provincial rent assistance through the CECRA for small businesses, but their landlord chose not to apply for the program.
  - iii. The ban will protect small businesses from being locked out or having their assets seized during COVID-19.

- O-Two Medical Technologies partnered with Linamar Corp. and other partners, including Bombardier, to produce these lifesaving devices to enhance future preparedness and help patients with severe cases of COVID-19 and other respiratory illnesses.
- Through the Ontario Together Fund, the government is delivering targeted investments that will increase the province's stockpile of Ontario-made products and personal protective equipment (PPE).

**30. September 11<sup>th</sup> - Ontario Supports Training for the IT & Tech Sectors**

- The Ontario government is investing more than **\$2.2 million** to **help over 600 job seekers in Ottawa** develop the skills they need to establish **careers in the technology and Information Technology (IT) sector**.
- The funding is being distributed as follows:
  - Ottawa Chinese Community Service Centre is receiving \$499,254 for an employer-led IT training project that will help up to 400 workers rapidly upgrade their skills and prepare them for high-demand jobs;
  - Lighthouse Labs is receiving \$456,646 to train up to 60 newcomer women in technical IT skills;
  - Information and Communications Technology Council is receiving \$497,155 to train 25 jobseekers in financial technology skills, followed by a work placement;
  - Carleton University is receiving \$466,302 to create accessibility videos and materials for employers and employees to support the employability of post-secondary students with disabilities; and
  - Le Collège La Cité is receiving \$313,951 to train up to 120 francophones in IT.
- Online job postings in the region show that software engineers and designers, and information system analysts are two of the top four in-demand workers.
- These projects encourage synergies between industry, education and training providers to drive innovation, help employers find skilled workers, and help job seekers find well-paid careers.

**31. September 11<sup>th</sup> - New Gold Mine Will Support Economic Recovery in Northern Ontario**

- The Ontario government is supporting the construction of **IAMGOLD's new Côté Gold Mine**, a project that will drive **long-term economic growth and support a strong recovery in Northern Ontario**.
- When fully operational, the mine is expected to **employ 450 people, generate more than \$5 billion in wages, and contribute \$10 billion to Ontario's gross domestic product** over its 18-year life span.

**32. September 10<sup>th</sup> - Governments Help Ontario Farmers Bring High-Quality Products to Market**

- The governments of Canada and Ontario are investing more than **\$7.9 million** through the **Canadian Agricultural Partnership** to help **farmers improve their business operations and bring more safe, high-quality foods to markets**.
- This funding will support more than **670 projects across Ontario** for eligible farmers and agri-food businesses.
  - The projects were approved following a competitive, merit-based application intake that took place from January 8 to January 29, 2020.
- Examples of projects supported through this programming include:
  - Improving food safety systems on farms to meet or exceed international certification standards;
  - Planting over-wintering cover crops to improve soil health and reduce soil erosion losses;
  - Actions to help prevent pest damage at greenhouse operations;
  - Developing a product that will open new sales markets for a farm business; and
  - Upgrades to animal-handling equipment and improved biosecurity measures.
- The funding is in addition to programming launched this year to assist the sector in meeting challenges related to the COVID-19 outbreak.

**33. September 3<sup>rd</sup> - Ontario extending protection to prevent temporary layoffs from automatically becoming permanent job losses**

- The Ontario government is **helping protect jobs and businesses by extending protection to prevent temporary layoffs from automatically becoming permanent job losses.**
- Although Ontario is now in Phase 3 of reopening, this extension will give businesses more time to reopen and return to full operations. This **extension will last until January 2, 2021.**
  - Under Ontario labour laws, termination of an employee after 13 weeks of being temporarily laid off triggers costly payouts which, for many businesses, could be the difference between survival and closure.
  - This regulatory amendment delays these terminations and severance liabilities.
- Employees at businesses that have fully reopened continue to have job protection through the [Infectious Disease Emergency Leave](#) if they need to stay home to isolate or quarantine or take care of a loved one due to COVID-19.
  - This includes parents who decide not to send their children back to school due to concerns about COVID-19.

**34. August 18<sup>th</sup> - Applications open for the Ontario Automotive Modernization Program**

- The Ontario government is launching the next round of applications for the [Ontario Automotive Modernization Program \(O-AMP\)](#).
- An important part of the government's *Driving Prosperity* auto plan, the **\$10-million O-AMP provides auto parts companies with funding to invest in new technologies and support innovation** in Ontario's automotive supply chains.

**35. June 17<sup>th</sup> (Update)- Ontario Implements Temporary Ban on Commercial Evictions: Currently Active**

June 17<sup>th</sup> Update

- On June 17<sup>th</sup>, the Ontario government passed the *Protecting Small Business Act*, **temporarily halting or reversing evictions of commercial tenants** and **protecting them from being locked out or having their assets seized** during COVID-19.
- The legislation applies to businesses that are eligible for federal/provincial rent assistance for evictions from **May 1, 2020** until **August 31, 2020**.
- Landlords and tenants are encouraged to participate in the **Canada Emergency Commercial Rent Assistance (CECRA)** for small businesses.
  - i. The pause on evictions does not apply to those participating in CECRA for small businesses, as the program requires landlords to enter into a rent reduction agreement with their impacted small business tenants and commits them to a moratorium on evictions for three months.

- In partnership with the federal government, Ontario is committing **\$241 million** to CECRA for small businesses, which will provide more than **\$900 million** in support for small businesses and their landlords.
  - i. CECRA for small businesses provides forgivable loans to eligible commercial landlords for the months of April, May, and June 2020.
  - ii. Small business landlords would be asked to forgive at least 25 per cent of the tenant's total rent, tenants would be asked to pay up to 25 per cent of rent and the provincial and federal governments would share the cost of the remaining 50 per cent.

  - iii. **Future-Proofing Main Street** will provide specialized and in-depth **digital transformation services** and support that helps existing main-street firms adapt to changes in their sector and thrive in the new economy.

**42. March 19<sup>th</sup> - Municipal Emergency Act, 2020 - Supply Chain - Temporary Changes to Municipal Noise By-Laws: Currently Active**

- The new legislation ensures that for the near future, the delivery of goods to Ontario's businesses and consumers isn't impacted by municipal noise by-laws that may unintentionally be impeding such deliveries when they are most urgently needed.
- The new legislation will waive local noise by-laws allowing delivery trucks to operate overnight.
- These temporary changes will allow businesses to transfer goods between their warehouses and retail stores 24 hours a day, seven days a week.

**43. March 19<sup>th</sup> - Commercial Vehicles - Extension of validation Periods for Driver, Vehicle and Carrier Products: Currently Active**

- New regulations include extensions for driver licences, licence plate validation, Ontario Photo Cards, and **Commercial Vehicle Operator Registration certificates**, among others.
- The Ministry of Transportation is also automatically extending the due dates for medical or vision reports
- This extension will be in place until such time that, based on the advice of Ontario's Chief Medical Officer of Health and public health officials, the current situation improves.

**45. October 15<sup>th</sup> - Delivering High-Speed Internet in Oxford County**

- Canada and Ontario are delivering on their commitment to create even more economic and educational opportunities in rural, remote and underserved areas of the province through an improved, modern broadband network in Southwestern Ontario.
- Today, the province announced that all contracts are signed in **Oxford County** through the **Southwestern Integrated Fibre Technology (SWIFT)** project, ensuring that construction of up to **\$9.9 million** in broadband infrastructure will now move forward.
- When complete, these projects will connect approximately **1,670 more homes and businesses in the area to fast, reliable internet.**
- Work continues to bridge the gaps in broadband access in Southwestern Ontario, as part of a combined **\$191 million** investment to bring fast, reliable internet to thousands of homes and businesses.

**46. October 15<sup>th</sup> - Ontario Adding Over 200 More Transitional Care Beds Across the Province**

- The Ontario government is expanding innovative and proven reactivation care models across the province by adding **over 200 more transitional care beds.**
- These new beds will help ease pressures on hospitals, reduce wait times for patients by getting those who no longer need to be in a hospital, but are waiting to transition to home, community or long-term care, the right level of care in the right setting, and help end hallway health care.
- Ontario will be developing five new reactivation care centres where patients, including those living with dementia or in need of personal support, will benefit from services such as physiotherapy, nursing and support for daily living, with a focus on restorative care to help improve their health outcomes.

  - City of Toronto

**48. October 14<sup>th</sup> - Ontario Hiring Hundreds More Contact Tracers and Case Managers**

- The Ontario government is taking immediate action to **expand case and contact management to help track, trace and isolate new cases of COVID-19.**
- The province has hired **100 new contact tracers**, many of whom are starting work this week, with up to **500 more recruits** expected to be hired by mid-November.
- These new positions are part the province's fall preparedness plan, [\*Keeping Ontarians Safe: Preparing for Future Waves of COVID-19\*](#), which dedicates **\$1.376 billion** to enhance and expand testing and contact tracing in the province.
- Ontario Public Service (OPS) staff are also volunteering for redeployment to provide surge support for contact tracing this fall and winter, and over 600 Statistics Canada employees have been onboarded since July to assist with contact follow-up.
- There are currently more than **2,750 case and contact management staff** active across all public health units, tracing and managing COVID-19 cases — up from approximately 1,500 staff in the spring.
  - These 600 new recruits and 600 personnel from Statistics Canada will bring the total number of case and contact management staff to nearly 4,000.

**49. October 9<sup>th</sup> - Ontario Implementing Additional Public Health Measures in Toronto, Ottawa and Peel Region**

- In consultation with the Chief Medical Officer of Health, the Public Health Measures Table, and local medical officers of health and other health experts, the Ontario government is **introducing additional targeted public health measures in the Ottawa, Peel, and Toronto public health unit regions.**
- These modified Stage 2 restrictions will be for a **minimum of 28 days** and reviewed on an ongoing basis.
- **Effective Saturday, October 10, 2020 at 12:01 a.m.**, these targeted measures are being implemented in Ottawa, Peel, and Toronto as a result of their higher than average rates of transmission. Measures under a modified Stage 2 include:
  - Reducing limits for all social gatherings and organized public events to a maximum of 10 people indoors and 25 people outdoors where physical distancing can be maintained. The two limits may not be combined for an indoor-outdoor event;
  - Prohibiting indoor food and drink service in restaurants, bars and other food and drink establishments, including nightclubs and food court areas in malls;
  - Closing of:
    - Indoor gyms and fitness centres (i.e., exercise classes and weight and exercise rooms);
    - Casinos, bingo halls and other gaming establishments;
    - Indoor cinemas;
    - Performing arts centres and venues;
    - Spectator areas in racing venues;
    - Interactive exhibits or exhibits with high risk of personal contact in museums, galleries, zoos, science centres, landmarks, etc.;
  - Prohibiting personal care services where face coverings must be removed for the service (e.g. makeup application, beard trimming);
  - Reducing the capacity limits for:

- Tour and guide services to 10 people indoors and 25 people outdoors
  - Real estate open houses to 10 people indoors, where physical distancing can be maintained.
  - In-person teaching and instruction (e.g. cooking class) to 10 people indoors and 25 people outdoors, with exemptions for schools, child care centres, universities, colleges of applied arts and technology, private career colleges, the Ontario Police College, etc.
  - Meeting and event spaces to 10 people indoors and 25 people outdoors, and
  - Limiting team sports to training sessions (no games or scrimmages).
- Schools, child care centres, and places of worship will remain open in these communities and must continue to follow the public health measures in place. Before-school and after-school programs will also be exempt from these new restrictions.
  - Effective [Tuesday, October 13, 2020 at 12:01 a.m.](#), updated public health measures will apply to wedding receptions, including new gathering limits of 10 people indoors and 25 people outdoors at event spaces.
  - As these necessary public health measures come at a cost to small businesses, Ontario has planned to and will make **\$300 million** available to assist significantly **affected businesses with fixed costs, including property taxes, hydro and natural gas bills.**
    - This support will be provided by the province and will be made available in any region where these measures are necessary. **More details will be released in the coming days.**
  - This funding builds on the actions the government has taken to support small businesses throughout the pandemic, including putting in place a temporary moratorium on commercial evictions, making **\$60 million** available for a \$1,000 grant for small businesses to offset the cost of personal protective equipment (PPE), and exploring options to permanently allow restaurants and bars to include alcohol with food as part of a takeout or delivery order.
- 50. October 9<sup>th</sup> - Increased COVID-19 Precautions for Congregate Care Settings**
- The Ontario Government is setting out **increased precautions for congregate care settings in areas where there is a high rate of community spread of COVID-19** to ensure the province's most vulnerable and those who care for them are safe.

- Those settings include homes serving adults with developmental disabilities, shelters for survivors of gender-based violence and human trafficking, children's residential settings, youth justice facilities and Indigenous Healing and Wellness Strategy residential programs that support Indigenous individuals and families both on- and off-reserve.
  - The ministry recognizes the importance of visits for both residents and their families and wherever possible, essential visits such as those necessary to maintain the health, wellness and safety of a resident will be permitted to continue unless the local public health unit directs otherwise as part of outbreak management.
    - An [essential visitor](#) may include, but is not limited to, a parent or guardian, a social service worker or a health care provider.
  - A list of the regions covered by each precaution level is posted [online](#). The province will update the list as the areas with higher community spread change.

**51. October 7<sup>th</sup> - Ontario Welcomes Construction of Largest Renewable Natural Gas Plant in the Province and New Program for Enbridge Customers**

- Ontario will soon be home to a **new renewable natural gas (RNG) facility**, which will create local jobs and stimulate regional economic development, while reducing greenhouse gas emissions in Canada.
- The **Niagara Falls Renewable Natural Gas plant** will be the largest of its kind in Ontario and will generate enough clean renewable energy from landfill waste to **heat 8,750 homes** across the country and **reduce greenhouse gas emissions by 48,000 tonnes**.
- The Ontario Energy Board (OEB) has also approved an application from Enbridge to implement a **pilot Voluntary Renewable Natural Gas Program in Ontario starting in 2021**.
  - Through the program, customers can choose to support the transition to clean energy through a small monthly contribution to purchase carbon-neutral renewable natural gas.
  - During the first five years of the program, Enbridge Gas anticipates up to 28,000 customers could participate reducing CO2 emissions by 8,000 tonnes, equivalent to taking 1,600 cars off the road for one year.

**52. October 7<sup>th</sup> - Ontario Helping Apprentices Cover Living Expenses during Training**

- The Ontario government is making the **skilled trades** more accessible by investing an additional **\$75 million** over the next two years **to help apprentices cover living expenses during their in-class training**.
- The government is also appointing a five-member Skilled Trades Panel to provide advice and recommendations to the Minister of Labour, Training and Skills Development on developing a new approach to training and certification.
- This \$75-million investment includes:
  - The **Grant for Apprentice Learning**, a \$5.8 million commitment to support those ineligible for Employment Insurance (EI) while attending in-class training, including a boost of \$1.3 million this year and next year.
  - The **Apprentice Development Benefit**, a \$24 million commitment to increase the maximum benefit rates for EI-eligible apprentices attending full-time in-class training, including a boost of \$4 million this year and next year.
  - The **In-Class Enhancement Fund**, a \$211.9 million commitment to support training providers so they can deliver higher quality training, including a boost of \$11.8 million this year and \$22.3 million next year.
  - The **Apprenticeship Capital Grant**, a \$24 million commitment to training providers to upgrade their facilities with state-of-the-art and modern equipment, including an additional \$10 million next year.
  - \$5.1 million for **training delivery agents**, and an additional \$500,000 for **pre-apprenticeship training service providers**, to assist them with implementing COVID-19 health and safety measures during the pandemic (e.g. purchase personal protective equipment, cleaning products and digital supports).
  - \$4.7 million as part of a multi-year \$19.4 million investment in the **development of a client-facing digital system** to support the skilled trades and apprenticeship system in Ontario. The portal will provide skilled trades and apprenticeship clients with secure and convenient access to online information and services and will bring Ontario in line with digital delivery channels in other provinces.
  - \$2.5 million this year and \$7.5 million next year to launch the new **non-repayable Tools Grant**.

**53. October 7<sup>th</sup> - Ontario Building a Modern, Connected and Comprehensive Mental Health and Addictions System**

- The Ontario government is providing an additional **\$176 million** this year to help **expand access for critical mental health and addictions supports** during COVID-19.
- This funding is part of the province's investment of **\$3.8 billion over 10 years** and enables Ontario's comprehensive plan, ***A Roadmap to Wellness***, to deliver high-quality care and build a modern, connected and comprehensive mental health and addictions system.
- The increased funding will help address urgent gaps in care, enhance access to mental health and addictions services, create new supports and expand programs in several priority areas, including:
  - Community-based services in English and French, including services for children and youth;
  - Mental health and justice services;
  - Supportive housing for individuals with serious mental health and addiction challenges, and who are either homeless or at risk of becoming homeless;
  - Community and residential addictions, including treatment and care for opioid addictions;
  - Increased supports for Indigenous peoples, families, and communities; and
  - More hospital in-patient beds for mental health and addiction patients.
- The Province also joins the Centre for Addiction and Mental Health (CAMH) in celebrating the **grand opening of the third phase** of a historic redevelopment project.
  - The **McCain Complex Care and Recovery Building** and the **Crisis and Critical Care Building** (Toronto) will transform mental health care in the province, with spaces that support recovery and promote community integration for patients in a connected and coordinated system of care.

  - If the home is experiencing an outbreak of COVID-19 the local public health unit will provide direction on further visitor restrictions and other measures.

  - Continuing **mobile testing and pop-up testing centres** to reach **vulnerable populations** and provide targeted testing for long-term care, congregate care, and other vulnerable populations;
  - **Expanding the number of pharmacies** where people with no symptoms within provincial testing guidance can get tested; and
  - **Implementing updated testing guidance for children** to help parents determine when it is most appropriate for students, children and their families to seek a test for COVID-19.
- Ontario is also taking longer-term actions to increase the province's test processing capacity so people can get their results faster, including:
- Increasing **testing and processing capacity to 50,000 tests** per day by **mid-October** and **68,000 tests per day by mid-November**; and

#### **New Public Health Measures**

- As the number of new cases continues to rise, the province is taking decisive action to prevent and stop the spread of the virus and avoid future lockdowns.
- They include **mandating the use of face coverings in all public indoor settings across the province**, such as businesses, facilities and workplaces, with limited exemptions, including corrections and developmental services.
- Targeted measures will also be implemented in **Ottawa, Peel, and Toronto** as a result of their higher than average rates of transmission. These include:
  1. Setting an **indoor capacity limit** to restrict occupancy at restaurants, bars and other food and drink establishments (including nightclubs) to the number of patrons who can maintain a physical distance of at least two metres from every other patron, to a

maximum of 100 patrons, permitting no more than six patrons per table, requiring operators to ensure patrons lining up or congregating outside of their establishment maintain physical distancing, and mandating that the name and contact information for each patron be collected;

2. Restricting group exercise classes at **gyms and other fitness settings** to 10 individuals, as well as restricting the total number of people allowed at these facilities to a maximum of 50; and
3. Setting a limit on the number of people allowed at **meeting and event facilities, including banquet halls**, to six people per table and 50 people per facility.

- This amended order will come into effect on **Saturday, October 3, 2020** at 12:01 a.m.
- In addition, the government is:
  - **Extending the pause on any further reopening of businesses, facilities, and organizations** for an additional 28 days, unless already permitted to open under O. Reg 364/20;
  - **Pausing social circles** and advising that all Ontarians allow close contact only with people living in their own household and maintain two metres physical distancing from everyone else.

**61. October 1<sup>st</sup> - Ontario Provides \$461 Million to Temporarily Enhance Wages For Personal Support Workers**

- The Ontario government is supporting **personal support workers (PSWs)** and **direct support workers in the home and community care, long-term care, public hospitals, and social services sectors** by investing **\$461 million to temporarily enhance wages**.
- This investment will help the province attract and retain the workforce needed to care for patients, clients and residents in response to the COVID-19 pandemic.
- The province is providing a temporary wage **increase effective October 1, 2020** to over **147,000 workers** who deliver publicly funded personal support services:

- \$3 per hour for approximately 38,000 eligible workers in home and community care;
  - \$3 per hour for approximately 50,000 eligible workers in long-term care;
  - \$2 per hour for approximately 12,300 eligible workers in public hospitals; and
  - \$3 per hour for approximately 47,000 eligible workers in children, community and social services providing personal direct support services for the activities of daily living.
- The temporary wage enhancement will be reviewed on a regular basis and **could extend through March 31, 2021**, in connection with regulations made under the Reopening Ontario (A Flexible Response to COVID-19) Act, 2020.
  - This temporary wage enhancement continues to build on the province's [COVID-19 fall preparedness plan](#), which includes an investment of \$26.3 million to support PSWs and supportive care workers.

**62. October 1<sup>st</sup> - Ontario Revises COVID-19 Screening Guidance for Schools and Child Care**

- In consultation with the Chief Medical Officer of Health, the Ontario government is **updating its COVID-19 school and child care screening guidance**.
- This additional information will help parents determine when it is most appropriate for students, children and their families to seek a test for COVID-19.
- The school and child care screening guidance is being updated with two sets of questions about symptoms and information to help parents make informed decisions about whether their children should attend school or child care, need to consult a health care provider, or get tested for COVID-19.
- The guidance can be found immediately at the [COVID-19 Screening Tool for Children in School and Child Care](#), and the refreshed online tool will launch on **Friday, October 2** for download.
- The **first set of questions** asks about symptoms such as fever or cough. Students and children with any of these symptoms will still be advised to stay home until they are able to consult with a health care provider and receive an alternative diagnosis or a negative COVID-19 test.

- Ontario has developed a comprehensive plan, ***Keeping Ontarians Safe: Preparing for Future Waves of COVID-19***, to ensure the health care system is prepared for the immediate challenges of the fall including future surges and waves of COVID-19 and flu season.

Reg 364/20: Rules for Areas in Stage 3** under the *Reopening Ontario (A Flexible Response to COVID-19) Act, 2020*, to tighten public health measures in response to the recent rise in cases of COVID-19.

  - Close all strip clubs across the province; and
  - Require businesses or organizations to comply with any advice, [recommendations](#), and instructions issued by the Office of the Chief Medical Officer of Health on screening for COVID-19.
- In addition, the province will work with the municipal sector and other partners to encourage increased enforcement of existing businesses, facilities, workplaces, etc. to comply with all public health and workplace safety measures and restrictions in the Stage 3 regulation.

**70. September 25<sup>th</sup> - Canada and Ontario Invest in Affordable Housing in Kemptville**

- The governments of Canada and Ontario are providing nearly **\$1.5 million** to help create **new affordable housing in Kemptville**.
- This investment will ensure more families, seniors, people with disabilities and those at risk of homelessness have access to stable housing in their community.
- Spearheaded by Community Living North Grenville, the new 11-unit affordable housing complex is located at 224 Jack Street.

**72. September 24<sup>th</sup> – Ontario Investing More Than \$1 Billion to Expand COVID-19 Testing and Contact Tracing**

- The Ontario government is building on the **largest provincial testing initiative in Canada** by providing **\$1.07 billion** to expand COVID-19 testing and case and contact management.

Less invasive collection methods, such as throat, nasal swabbing and saliva collection will now be used in addition to nasopharyngeal swabs to test for COVID-19.
  - **More Testing Capacity:** Ontario will continue to expand the capacity of the provincial lab network so more tests can be processed and testing targets can be achieved.
  - **More Case and Contact Managers:** Ontario will continue to add case and contact management staff to prevent the spread of the virus. There are currently more than 2,750 case and contact management staff active across all public health units tracing and managing COVID-19 cases, up from approximately 1,500 staff in the spring.

**73. September 24<sup>th</sup> - Ontario Extends Critical Delivery Program for Seniors and People with Disabilities**

- The Ontario government is releasing the **2019-20 Public Accounts** and delivering on the government's commitment to **restore transparency and accountability to the province's finances**.
- For the third year in a row, the Auditor General has provided a **clean audit opinion on the Province's Public Accounts**.
- The Public Accounts provides a retrospective look at the government's fiscal performance over the previous fiscal year, comparing the financial results against those projected in the 2019 Budget.
- The Public Accounts reports a 2019-20 **deficit** of \$8.7 billion — **\$1.6 billion lower than the 2019 Budget projection** — reflecting stronger revenue growth led by higher than anticipated employment and wage growth and housing resales in 2019.
- Total expenses for 2019-20 were \$3.7 billion higher than the previous year, mainly driven by increased investment in the health sector, including funding to prevent and contain the spread of COVID-19 in long-term care homes, and the education sector.
- To build on the government's capacity for enterprise risk management, the government of Ontario recently created the Office of the Comptroller General, a new deputy minister-level position tasked with identifying and mitigating potential financial and policy risks before they take hold, protecting taxpayer dollars in the process.

**79. September 22<sup>nd</sup> - Ontario Set to Launch Largest Flu Immunization Campaign in Province's History**

- The Ontario government is implementing **the largest flu immunization campaign in Ontario's history**.
  - The province is investing almost **\$70 million to purchase flu vaccines** to deliver a robust and expanded campaign this year.
- The campaign is part of the province's comprehensive plan to prepare the health system for a second wave of COVID-19.

  - Launching a public education campaign to encourage getting the flu shot.
- The flu shot will be available in the **coming weeks at primary care provider offices and public health units** for anyone over the age of six months, and **participating pharmacies for anyone five years of age or older**.

**80. September 19<sup>th</sup> - Ontario Limits the Size of Unmonitored and Private Social Gatherings across Entire Province**

- The Ontario government, in consultation with the Chief Medical Officer of Health and the Public Health Measures Table, is **reducing limits on the number of people permitted to attend unmonitored and private social gatherings across the entire province**.
  - Earlier this week, the government imposed these restrictions in Toronto, Peel Region and Ottawa.

- These new limits are **effective immediately**.

- The Ontario government has introduced legislation **to provide financial assistance to more veterans in need.**
- **The Soldiers' Aid Commission Act, 2020, if passed**, will ensure **veterans of all ages and their families**, not just those who served in the Second World War and the Korean War, will be eligible to apply for financial assistance.
- To support the next generation of service men and women, the government is proposing to increase its investment in the [Soldiers' Aid Commission](#) to more than \$1.5 million annually.
- The funding provided by the commission will continue to support veterans who are unable to pay for health-related items such as hearing aids, wheelchairs and glasses, home-related items such as home accessibility modifications and repair costs, and personal items and support services such as clothing and counselling.

**85. September 17<sup>th</sup> - Ontario Introduces Legislation to Freeze Residential Rent in 2021**

- The Ontario government has introduced the **Helping Tenants and Small Businesses Act** that would, **if passed, freeze rent in 2021 for most rent-controlled and non-rent-controlled residential units**.
  - The bill would provide the vast majority of Ontario's tenants with financial relief as the province continues down the path of renewal, growth and economic recovery.
- The Helping Tenants and Small Businesses Act also **proposes to change the Commercial Tenancies Act to extend the temporary ban on evictions for commercial tenants**.
  - The ban was initially in place from May 1, 2020 to August 31, 2020, to align with the Canada Emergency Commercial Rent Assistance (CECRA) for small businesses.
  - This temporary ban would continue to apply to businesses that are eligible for federal-provincial rent assistance through the CECRA for small businesses, but their landlord chose not to apply for the program.
  - The ban will protect small businesses from being locked out or having their assets seized during COVID-19.

**86. September 17<sup>th</sup> - Lower Limits for Unmonitored and Private Social Gatherings in Ottawa, Peel and Toronto Regions**

- In consultation with the Chief Medical Officer of Health, local medical officers of health and local municipal leaders, the Ontario government has set a **new limit reducing the number of people permitted to attend unmonitored social gatherings and organized public events in three regions** experiencing higher rates of transmission of COVID-19.

  - **10 people at an indoor event** or gathering (previous limit of 50); or
  - **25 people at an outdoor event or gathering** (previous limit of 100).
- The new limits will only apply to persons within the boundaries of **the following public health units**:
  - Ottawa Public Health;
  - Peel Public Health; and
  - Toronto Public Health.
- Indoor and outdoor events and gatherings cannot be merged together. These are not accumulative and gatherings of 35 (25 outdoors and 10 indoors) are not permitted.
- The new limits **will not apply** to events or gatherings held in staffed businesses and facilities, such as bars, restaurants, cinemas, convention centres or banquet halls, gyms, and recreational sporting or performing art events.
  - Existing rules, including public health and workplace safety measures, for these businesses and facilities continue to be in effect.
- These new compliance mechanisms are the most stringent in all of Canada.

**COVID-19 symptoms and risk factors that is required before attending school.**

- The results will let parents, students, and education staff know whether they should attend school each day or guide at-risk individuals to proper resources.
- This tool is another layer of prevention that the province is using to protect the health and safety of students, staff, and the communities where they live and work.
- Users will simply respond to clinician-informed symptom and risk questions, and the tool will then immediately inform users whether it is safe to attend school that day.
  - The tool protects privacy and does not collect any personal health information.
  - The tool was also developed in house by the Ontario Digital Service at no additional cost to taxpayers.
- Earlier this summer, Ontario unveiled the nation's most [comprehensive plan for the safe reopening of schools in September](#).
  - The plan is supported by **\$1.3 billion** in critical supports to hire more teachers and increase physical distancing, purchase personal protective equipment (PPE), enhance cleaning of schools and school buses, improve ventilation, hire more custodians, and add more school leadership positions and administrative support for virtual schools.
  - In addition, local public health units have filled **over 530 nursing positions**, or 85 per cent, of the additional 625 nursing positions created to help keep students and staff safe.
  - In order to ensure that schools are supported from the start of the school year, several public health units have temporarily redeployed existing nurses while recruitment activities continue.

**88. September 14th - Health Preparedness and Rebuilding the Economy Top  
Priorities in Ontario's Fall Legislative Agenda**

- The Ontario government is returning to the legislature as of September 14<sup>th</sup>, ready to continue implementing its made-in-Ontario plan for growth, renewal and long-term recovery.
- The government's fall legislative agenda will build on the work undertaken over the summer, focusing on job creation, skills training, attracting investment, strengthening communities, and fortifying the front lines of the province's health care system.
- Priorities for the upcoming session include:
  - Investing in **Ontario's health care system** to ensure the province is prepared for a potential second wave of COVID-19 and for any future public health challenges;
  - Building **Ontario's production capacity** for personal protective equipment, ventilators and other medical gear so the province never has to rely on any other jurisdiction again for these critical supplies;
  - **Protecting families and those most vulnerable** and helping them get back on their feet as the province reopens;
  - Helping **young people and workers** receive the **skills training** they need to join the modern workforce and contribute to the recovery of the province;
  - Accelerating the **construction of critical highway, transit and broadband infrastructure projects** to create jobs and boost the local economies of communities across Ontario;
  - **Providing relief to Mainstreet Ontario and small business owners** so they can recover from the impact of COVID-19 faster and get back to the work of building their business; and
  - **Expanding manufacturing** by creating the conditions to bring investment and jobs to the province and world-class, Ontario-made products to consumers around the world.
- From March to July, the government was successful in passing 18 pieces of legislation, including emergency measures needed to protect public health and prepare for economic recovery, such as the Economic and Fiscal Update Act, the COVID-19 Support and Protection Act, the Protecting Small Business Act, and the COVID-19 Economic Recovery Act.

**89. September 14<sup>th</sup> - Ontario Investing in Hospital Upgrades and Repairs**

- The Ontario government is investing **\$175 million** this year to address **critical upgrades, repairs and maintenance in 129 hospitals** across the province, including **\$50 million for COVID-19** related and other urgent projects.
  - Through the **Health Infrastructure Renewal Fund**, this funding will help hospitals maintain their infrastructure and ensure a safe and comfortable environment for patients to receive care.
- As the government continues to work toward bringing Ontario's world class health care system into the 21st century, this funding will help hospitals address urgent issues such as upgrades or replacement of roofs, windows, security systems, backup generators and fire alarms.
- Projects will also support hospitals in their ongoing response to COVID-19, such as updating HVAC systems to enhance patient and staff safety, creating additional isolation spaces and negative air pressure flow rooms to increase capacity, and enhancing infection prevention and control measures.

**90. September 11<sup>th</sup> - Ontario Launches COVID-19 School and Licensed Child Care-specific Web Page**

- The government is launching a [webpage to report COVID-19 cases in schools and child care centres](#).
- This page will be **updated every weekday** with the most up-to-date COVID-19 information available, including a summary of cases in schools and licensed child care centres and agencies, if a COVID-19 case is confirmed at a school and where the numbers come from.

**91. September 10<sup>th</sup> - Ontario Expanding Innovative Mental Health and Addictions Services**

- The Ontario government is providing an **additional \$14.75 million to increase access to mental health and addictions services across the province**.

  - **\$4.75 million** to support **culturally safe services for Indigenous communities**, with a focus on children and youth; and
  - **\$3 million** to expand **virtual and online services** including addictions supports, Internet-based Cognitive Behavioural Therapy (iCBT) and an online peer support community for mental health.
- The Ontario government is investing an additional **\$2.9 million** in eight research projects that aim to support Ontario's response to COVID-19.
  - These projects will focus on a wide variety of areas such as supporting the mental health and well-being of families and children, assessing the long-term health effects of COVID-19, the development of an app to better manage the care of patients, and an evaluation of the effectiveness of wearing masks to block the virus.
  - These eight research projects were submitted through the **Ontario Together portal**. This is in addition to the 35 projects selected through the \$20 million [Ontario COVID-19 Rapid Research Fund](#).

**93. September 8<sup>th</sup> - \$1.3 Billion Investment to Reopen Schools Safely**

- As students, teachers and staff return to school, the Ontario government is providing up to **\$1.3 billion** in critical supports and has delivered more than **37 million pieces of personal protective equipment (PPE)** to safely **reopen classrooms** across the province.
- The government has taken the following steps to make schools as safe as possible:
  - Providing more funding than any jurisdiction in the country to implement physical distancing measures, support hiring of up to **1,300 custodians** and adopt enhanced cleaning protocols in schools and on school buses, and hire more teachers to reduce class sizes.
  - Hiring up to **625 school-focused nurses** to provide rapid-response support to schools and boards, and facilitate public health measures, including screening, surveillance testing, tracing and mitigation strategies.
  - Working in collaboration with the Ministry of Government and Consumer Services to ensure that sufficient PPE has been delivered to all 72 school boards and 10 education authorities, including more than **19.5 million masks, 16 million gloves, 317,000 face shields, 320,000 bottles of hand sanitizer, and 218,000 containers of disinfectant**, among other critical supplies; and,
  - Providing students and families with clear and transparent standards for those that choose fully remote virtual learning, which is teacher-led, timetabled, live, synchronous, and on a regular daily schedule.
- The commitment of up to \$1.3 billion in funding to support the safe reopening of our schools is in addition to the landmark investment of over **\$25.5 billion in education**, which represents an **increase of over \$700 million for the 2020-21 school year**.

**94. Emergency Assistance – Support for individuals and families in financial crisis –  
Currently Active**

- As part of *Ontario's Action Plan: Responding to COVID-19*, a **\$17 billion** package with funding targeted to help families and a variety of sectors across the province, the Ontario government is providing **\$52 million** to better support individuals and families in financial crisis.
- This funding will support those who are not able to access federal assistance to cover needs such as food costs, rent, medicine and other essential services during this time.

- *Eligibility*
  - i. Applicants may qualify if they live in Ontario (not a visitor or tourist), are in a crisis or emergency situation, and do not have enough money for things like food and housing. For example, a crisis or emergency includes situations where applicants:
    1. Have been affected by COVID-19
    2. Are being evicted from their home
    3. Are in or are leaving an abusive relationship
    4. Are worried about their safety
  
- Those receiving assistance from Ontario Works or the Ontario Disability Support Program are not eligible for this program.

**95. October 16<sup>th</sup> – Government of Canada launches new COVID-19–related challenges to help reduce environmental impact of PPE in Canada**

- Today the Federal Government announced the launch of **two challenges through the Innovative Solutions Canada (ISC) program** to make personal protective equipment (PPE) more compostable and recyclable.
  - [Recycling technologies for disposable \(single-use\) PPE used in health care sector:](#)  
National Research Council Canada (NRC), in collaboration with Environment and Climate Change Canada (ECCC) and Health Canada (HC), is seeking solutions for the efficient and cost-effective recycling of disposable PPE waste generated in the Canadian health care system.
  - [Compostable disposable surgical masks and compostable disposable respirators used in the Canadian health care system:](#)  
NRC, in collaboration with ECCC, HC and Natural Resources Canada, is seeking solutions for the manufacturing of compostable disposable surgical masks and compostable disposable respirators to be used by health care workers.
- These challenges will close on **November 6 and 17, 2020**, respectively.
- Through the **ISC Challenge Stream**, the Government of Canada invites small and medium-sized Canadian enterprises to propose innovations that address the requirements of published challenges.
  - Under these two challenges, successful applicants could receive up to \$300,000 to develop a proof of feasibility. If accepted into Phase 2, companies could receive up to \$1 million to develop a working prototype.

**103. October 9<sup>th</sup> - Government announces new, targeted support to help businesses through pandemic**

- The Federal government has announced their intention to introduce **new, targeted supports to help hard-hit businesses and other organizations experiencing a drop in revenue.**
- The government **plans to introduce legislation** to provide support that would help these businesses safely get through the second wave of the virus and the winter, cover costs so they can continue to serve their communities, and be positioned for a strong recovery, including:
  - The **new Canada Emergency Rent Subsidy**, which would provide simple and easy-to-access **rent and mortgage support until June 2021** for qualifying organizations affected by COVID-19.
    - The rent subsidy would be **provided directly to tenants**, while also **providing support to property owners.**

- The new rent subsidy would support businesses, charities, and non-profits that have suffered a revenue drop, by subsidizing a percentage of their expenses, on a sliding scale, up to a **maximum of 65 per cent of eligible expenses until December 19, 2020**.
  - Organizations would be able to make claims retroactively for the period that began September 27 and ends October 24, 2020.
  
- A top-up **Canada Emergency Rent Subsidy of 25 per cent for organizations temporarily shut down by a mandatory public health order** issued by a qualifying public health authority, in addition to the 65 per cent subsidy.
  
- The **extension of the Canada Emergency Wage Subsidy until June 2021**, which would continue to protect jobs by helping businesses keep employees on the payroll and encouraging employers to re-hire their workers.
  - The subsidy would remain at the current subsidy rate of up to a maximum of 65 per cent of eligible wages until **December 19, 2020**.
  - This measure is part of the government’s commitment to create over 1 million jobs and restore employment to the level it was before the pandemic.
  
- **An expanded Canada Emergency Business Account (CEBA)**, which would enable businesses, and not-for-profits eligible for CEBA loans—and that continue to be seriously impacted by the pandemic—to **access an interest-free loan of up to \$20,000, in addition to the original CEBA loan of \$40,000**.
  - Half of this additional financing would be forgivable if repaid by December 31, 2022.
  - Additionally, the application deadline for CEBA is being extended to December 31, 2020.
  - Further details, including the launch date and application process will be announced in the coming days.
  - An attestation of the impact of COVID-19 on the business will be required to access the additional financing.

- The Federal government has announced **\$10 billion in new major infrastructure initiatives** to create jobs and economic growth.
- The **Canada Infrastructure Bank's (CIB)** Growth Plan will help Canadians get back to work and is expected to create approximately **60,000 jobs across the country**.
- The three-year plan will connect more households and small businesses to high-speed Internet, strengthen Canadian agriculture, and help build a low-carbon economy.
  
- The Growth Plan will invest in five major initiatives:
  - **\$2.5 billion** for clean power to support renewable generation and storage and to transmit clean electricity between provinces, territories, and regions, including to northern and Indigenous communities.
  - **\$2 billion** to connect approximately 750,000 homes and small businesses to broadband in underserved communities, so Canadians can better participate in the digital economy.
  - **\$2 billion** to invest in large-scale building retrofits to increase energy efficiency and help make communities more sustainable.
  - **\$1.5 billion** for agriculture irrigation projects to help the agriculture sector enhance production, strengthen Canada's food security, and expand export opportunities.
  - **\$1.5 billion** to accelerate the adoption of zero-emission buses and charging infrastructure so Canadians can have cleaner commutes.

  - The **Short-Term Compensation Fund for Canadian audiovisual productions** is a response to a pressing demand of producers that was identified at roundtables and meetings.
  - The fund will make as much as **\$50 million** available for the industry.
  - Administered by Telefilm Canada along with the Canada Media Fund, this funding will compensate independent production companies for the interruption or shutdown of an eligible audiovisual production, due to confirmed cases of COVID-19.

June 30<sup>th</sup> Update

- To simplify the application process for all applicants, the government is removing the requirement to claw-back insurance proceeds and provincial rent supports from the CECRA forgivable loan amount for both existing and new applicants.
  - i. Existing applicants who are affected will be notified and will have any previously clawed-back amounts restored to their forgivable loan.
- Those who qualified for the CECRA based on existing program parameters will be able to apply soon for the additional one month based on having a 70% revenue decline for April, May and June, i.e., without reassessing whether they continue to have a 70% revenue decline in July.
  - i. Participation in the one-month extension is voluntary.
  - ii. Only those tenants approved in the April, May and June application are eligible for the July extension.
- Existing applicants **need to reapply** for the month of July and have until **September 14, 2020**.
- New applicants have the choice of applying for the three-month initial period or four months, but need to do so by the original date of **August 31, 2020**.

- Small business landlords would be asked to **forgive at least 25 per cent** of the tenant's total rent, **tenants would be asked to pay up to 25 per cent of rent** and the **provincial and federal government would share the cost of the remaining 50 per cent**.
- The province is committing **\$241 million** through the new **Canada Emergency Commercial Rent Assistance Program (CECRA)**.
- The total amount of provincial-federal relief that would be provided is more than **\$900 million**, helping to ensure small businesses are ready to reopen their doors when the emergency measures are lifted.
- The CECRA will provide **forgivable loans** to eligible **commercial property owners** experiencing potential rent shortfalls because their small business tenants have been heavily impacted by the COVID-19 crisis.
- To receive the loan, property owners will be required to **reduce the rental costs of small business** tenants for **April to July 2020** by at least **75 per cent** and commit to a moratorium on evictions.
- The forgivable loans would be disbursed directly to the mortgage lender of the commercial property in question.
- As part of *Ontario's Action Plan: Responding to COVID-19*, the Government has implemented a series of cash flow supports amounting to **\$10 billion** to help support jobs and the economy (see for details) .
- How does the program work?

- The program has been developed to share the cost between small business tenants and landlords.
  - Small business tenants and landlords would each be asked to pay **25 per cent of the before profit costs** and the provincial and federal government would cost **share the remaining 50 per cent**.
  - The **loans will be forgiven** if the mortgaged property owner agrees to reduce the eligible small business tenants' rent by at least 75 per cent for the three corresponding months under a rent forgiveness agreement, which will include a term not to evict the tenant while the agreement is in place.
  - For example, a monthly rent for a small business is \$10,000. In this example, assume the landlord doesn't make a profit. The landlord forgoes \$2,500 (25 per cent of rent). The small business would be responsible for paying \$2,500 (25 per cent of rent). The government would cover the remaining \$5,000, with \$3,750 from the federal government (37.5 per cent of rent) and \$1,250 (12.5 per cent of rent) from the provincial government.
- How long would a commercial property owner have to apply for OCECRA?
  - The CECRA for small businesses is administered by the CMHC and will be available until **August 31, 2020**. Support will be retroactive to April 1, covering April, May, June and July 2020.
- What are the eligibility requirements for small businesses?
  - An eligible small business tenant is one that:
    - Pays monthly **rent not exceeding \$50,000** in gross rent payments; and is,
    - A non-essential small business that has temporarily closed, or who is experiencing a 70 per cent drop in pre-COVID-19 revenues.
      - a. There are 2 scenarios by which to calculate the 70% reduction in revenues:
        - i. If a small business was operating during April – June 2019, then compare the gross revenues

- from April, May and June of 2020 to the revenues of April, May and June of 2019.
- ii. If the small business was not operating during April – June 2019, then compare the average gross revenues from April, May and June of 2020 to the average gross revenues for January and February 2020.
  - Generate no more than **\$20 million** in gross annual revenues, calculated on a consolidated basis (at the ultimate parent level) \*\*
  - Not-for-profit organizations and charitable entities would also be considered for the program.
- Are there any eligibility requirements for commercial property owners?
  - The OCECRA would apply to commercial properties with small business tenants.
  - Commercial properties with a residential component, and residential mixed-use properties with a 30 per cent commercial component, would be equally eligible for support with respect to their commercial tenants.
  - If a property owner does not have a mortgage secured by a commercial rental property, the property owner should contact Canada Mortgage and Housing Corporation (CMHC) to discuss program options, which may include applying funds against other forms of debt facilities or fixed cost payment obligations (e.g. utilities).

August 31<sup>st</sup> (Update) Government announces greater flexibility and extension of Canada Emergency Business Account

- The Federal Government has today announcing that the **application deadline for the Canada Emergency Business Account (CEBA) is extended from August 31 to October 31, 2020**.
- The government is working closely with financial institutions to make the CEBA program available to those with qualifying payroll or non-deferrable

expenses that have so far been unable to apply due to not operating from a business banking account.

1. Further details on these changes will be released in coming days, including a new business account opening process through which qualifying businesses will be able to apply.

May 19<sup>th</sup> Update

- o As of May 19<sup>th</sup>, the **eligibility criteria** for the Canada Emergency Business Account (CEBA) has been expanded to include many **owner-operated small businesses**.
  - i. This means that owner-operated small businesses that had been ineligible for the program due to their lack of payroll, sole proprietors receiving business income directly, as well as family-owned corporations remunerating in the form of dividends rather than payroll will become eligible (**Effective June 19<sup>th</sup>, 2020**)
- o This extended measure will help small businesses protect the jobs that Canadians rely on.
- o Funding will be delivered in partnership with financial institutions.

To qualify under the expanded eligibility criteria, applicants with payroll lower than \$20,000 would need:

- i. A business operating account at a participating financial institution
  - ii. A Canada Revenue Agency business number, and to have filed a 2018 or 2019 tax return.
  - iii. Eligible non-deferrable expenses between \$40,000 and \$1.5 million. Eligible non-deferrable expenses could include costs such as rent, property taxes, utilities, and insurance.
- o CEBA provides much needed credit for small businesses to pay for immediate operating costs such as payroll, rent, utilities, insurance, property tax, or debt service. It is **100 per cent** funded by the Government of Canada.
  - o **Eligibility for the program has been expanded.** The Canada Emergency Business Account (CEBA) will now be available to businesses which paid up to **\$1.5 million in total payroll in 2019** and operating as of March 1, 2020.
  - o This includes smaller (i.e., micro) businesses and other eligible employers such as not-for-profits.

**118. August 24<sup>th</sup> - New temporary public policy will allow visitors to apply for a work permit without having to leave Canada**

- Visitors who are currently in Canada and have a **valid job offer** will be able to apply for an **employer-specific work permit** and, if approved, **receive the permit without having to leave the country**, thanks to a new public policy announced today.
- This temporary policy change **takes effect immediately** and will benefit employers in Canada who continue to face difficulties finding the workers they need, as well as temporary residents who would like to contribute their labour and skills to Canada's recovery from the COVID-19 pandemic.
- To be eligible, an applicant looking to benefit from this temporary public policy must
  - i. have valid status in Canada as a visitor on August 24, 2020 and remain in Canada
  - ii. have a job offer
  - iii. submit an application for an employer-specific work permit that is supported by a Labour Market Impact Assessment (LMIA) or an LMIA-exempt offer of employment, no later than March 31, 2021
  - iv. meet all other standard admissibility criteria
- This temporary public policy also provides the opportunity for applicants who meet these criteria and who had a valid work permit in the past 12 months to begin working for their new employer before their work permit application has been fully approved.

**119. August 24<sup>th</sup> (Update) - Canada Emergency Wage Subsidy (CEWS) - 75% Wage Subsidy - (Currently Accepting Applications– Direct deposits will begin to appear in employers' accounts as of May 7<sup>th</sup>)**

August 17<sup>th</sup> Update

- The Canada Emergency Wage Subsidy (CEWS) has supported more than **3 million Canadians** since the start of the COVID-19 pandemic, providing support to businesses so they can keep their workers, including furloughed workers, on the payroll.

- The Federal government has announced that the government proposes to **extend the current treatment of furloughed employees under the CEWS program by 4 weeks – from August 30 to September 26.**
- This would mean that employers who qualify for the CEWS would be able to continue to claim up to a maximum benefit of \$847 per week to support remuneration for each of their furloughed workers.
- Further details about the calculation of CEWS for furloughed workers for remaining periods of the program will be announced in the coming weeks.

August 17<sup>th</sup> Update

- To ensure that Canadian workers and businesses are in a better position as our economy safely re-opens, the Government of Canada has recently implemented **changes to the CEWS** that broaden the reach of the program and provide more targeted support.
- The Canada Revenue Agency has **opened applications for Period 5** – the first period of the enhanced CEWS program (as of August 17<sup>th</sup>).
- The Canada Revenue Agency's updated [CEWS calculator](#) can help small and large employers alike, by guiding them through a step-by-step process to prepare their applications and giving them a preview of the subsidy they may qualify for, based on the information they enter.
- Eligible employers can apply for period 5 of the CEWS through [My Business Account](#) or through the [CRA's web form application](#).
- The CEWS has provided **\$26.58B** in subsidies to more than **275,000 employers**, supporting millions of workers.

Program changes for Periods 5-9 include:

- The extension of the CEWS, including redesigned program details, until November 21, 2020.
- Increased eligibility, meaning that all eligible employers who've experienced a revenue drop can now qualify for a base subsidy. The subsidy amount is based on the revenue drop.
- Employers who are especially hard-hit can qualify for a top-up of up to 25%.
- Provide certainty for employers that have already made business decisions for July and August, by ensuring they will not receive a subsidy rate lower than they would have under the previous rules.

- The Federal government has **announced changes** to the CEWS that would broaden the reach of the program and provide better targeted support so that more workers can return to their jobs quickly as the economy restarts.

The changes include:

- Allow the extension of the CEWS until **December 19, 2020**, including redesigned program details until November 21, 2020.
- Make the subsidy accessible to a **broader range of employers by including employers with a revenue decline of less than 30 per cent** and providing a gradually decreasing base subsidy to all qualifying employers.
  - This would help many struggling employers with less than a 30-per-cent revenue loss get support to keep and bring back workers, while also ensuring those who have previously benefited could still qualify, even if their revenues recover and no longer meet the 30 per cent revenue decline threshold.
- Introduce a **top-up subsidy** of up to an additional 25 per cent for employers that have been most adversely affected by the pandemic.
  - This would be particularly helpful to employers in industries that are recovering more slowly.
- Provide certainty to employers that have already made business decisions for July and August by ensuring they would not receive a subsidy rate lower than they would have had under the previous rules.
- Address certain technical issues identified by stakeholders.

Original Announcement

- To support businesses that are facing revenue losses and to help prevent lay-offs, the government is proposing to provide eligible employers a temporary wage subsidy.
- The program was originally set to end June 6<sup>th</sup>. **The program will now be extended to December 2020.**
- The Government will consult with key business and labour representatives over the next month on **potential adjustments to the program** to incent jobs and growth, including the **30 per cent revenue decline threshold**.

- **May 15<sup>th</sup> Update** - The approval of regulations to extend eligibility for the CEWS to ensure that it continues to support those employers and workers hardest hit by the COVID-19 pandemic have been announced.
- These regulations **extend eligibility** for the CEWS to the following groups:
  - Partnerships that are up to 50-per-cent owned by non-eligible members;
  - Indigenous government-owned corporations that are carrying on a business, as well as partnerships where the partners are Indigenous governments and eligible employers;
  - Registered Canadian Amateur Athletic Associations;
  - Registered Journalism Organizations; and
  - Non-public colleges and schools, including institutions that offer specialized services, such as arts schools, driving schools, language schools or flight schools.
- The Government also intends to **propose legislative amendments** to ensure that the CEWS continues to meet its objectives. These proposed amendments would:
  - Provide flexibility for employers of existing employees who were not regularly employed in early 2020, such as seasonal employees;
  - Ensure that the CEWS applies appropriately to corporations formed on the amalgamation of two predecessor corporations and
  - Better align the treatment of trusts and corporations for the purpose of determining CEWS eligibility.

  - i. **75% wage subsidy** for qualifying businesses retroactive to **March 15, 2020**.
  - ii. **Eligible employers would include** individuals, taxable corporations, partnerships consisting of eligible employers, non-profit organizations and registered charities.
  - iii. **Eligible remuneration** may include salary, wages, and other remuneration like taxable benefits.
  - iv. This subsidy would be available to eligible employers that see a **drop of at least 15 per cent of their revenue in March 2020 and 30 per cent for the following months**.
  - v. An employer's revenue for this purpose is its revenue in Canada earned from arm's-length sources.
  - vi. Would apply at a rate of **75%** of the first **\$58,700** normally earned by employees – representing a benefit of up to **\$847** per week.
  - vii. The easiest way to apply for the CEWS is through [My Business Account](#) or [Represent a Client](#).
  - viii. CEWS claims will be subject to verification by the CRA. **Funds for approved applications will begin to be released on May 5<sup>th</sup> appearing in employers' accounts starting May 7<sup>th</sup>**.
  - ix. The pre-crisis remuneration for a given employee would be based on the average weekly remuneration paid between **January 1 and March 15** inclusively.
  - x. There would be no overall limit on the subsidy amount that an eligible employer may claim.
  - xi. Eligible employers would include **employers of all sizes** and across all sectors of the economy, with the exception of public sector entities.
  - xii. Beginning **April 27, 2020**, certain financial institutions will offer **CRA direct deposit online enrolment for business payroll accounts** through their websites, helping businesses get their payments quickly and securely.
  - xiii. Employers can sign up for direct deposit with their financial institutions even after applying for the CEWS.
  - xiv. Visit [Canada.ca/cra-direct-deposit](https://Canada.ca/cra-direct-deposit) or your financial institution's website for more information.
  - xv. If employers are not registered for direct deposit, they should allow additional time for their cheque to be delivered by mail to the address on their payroll account (RP).

- xvi. Canadians can receive the CEWS wage subsidy or the Canada Emergency Response Benefit (CERB) — not both.
  - xvii. **100% refund** for certain employer-paid contributions to Employment Insurance, the Canada Pension Plan, the Quebec Pension Plan, and the Quebec Parental Insurance Plan.
  - xviii. This refund covers 100% of employer-paid contributions for eligible employees for each week throughout which those employees are on leave with pay and for which the employer is eligible to claim the CEWS for those employees.
  - xix. Employers would be allowed to calculate their revenues under the accrual method or the cash method, but not a combination of both. Employers would select an accounting method when first applying for the CEWS and would be required to use that method for the entire duration of the program.
  - xx. For **registered charities and non-profit organizations**, the calculation will include most forms of revenue, excluding revenues from non-arm's length persons. These organizations would be allowed to choose whether or not to include revenue from government sources as part of the calculation. Once chosen, the same approach would have to apply throughout the program period.
- In order to address the realities faced by the **not-for-profit sector, high growth companies and new businesses**, the Government has allowed for additional flexibility:
    - To measure their revenue loss, employers have the flexibility to compare their 2020 revenue to that of the same month of 2019, or to an average of their revenue earned in applicable months.
    - In recognition that the time between when revenue is earned and when it is paid could be highly variable in certain sectors of the economy, employers be allowed to measure revenues either on the basis of accrual accounting (as they are earned) or cash accounting (as they are received).
  - All employers would be expected to at least make best efforts to top up salaries to 100% of the maximum wages covered.
  - Those organizations that do not qualify for the Canada Emergency Wage Subsidy may continue to qualify for the previously announced wage subsidy of 10 per cent of remuneration paid from March 18 to before June

20, up to a maximum subsidy of \$1,375 per employee and \$25,000 per employer (see [April 27th \(Update\) - 10% Wage Subsidy: Effective Immediately](#) for more details).

- An updated and improved **Canada Emergency Wage Subsidy online calculator** has been launched today
  - i. It will help small and large employers alike prepare to apply for the next period of the CEWS program, which will open for applications on **August 17, 2020**.
  - ii. The CEWS calculator can be found on the CRA's [Canada Emergency Wage Subsidy web page](#), which includes detailed information to help employers understand how the CEWS can support their employees and operations, **who is eligible to apply**, and **how claim periods are structured**.
  - iii. The calculator uses a step-by-step approach to get employers to enter information about their business situation to provide an **estimate of the subsidy they can expect to receive**.
  - iv. The calculator also includes **printable spreadsheet and statement** features that employers can use to view their claim at a glance and

enter required information into the CEWS application form quickly and easily.

- The CRA will open applications for **CEWS Period 5 on August 17, 2020**.

  - ii. Add storage capacity for unsold product;
  - iii. Comply with new health and safety measures for workers;
  - iv. Support new manufacturing/automated technologies to improve productivity and quality of finished seafood products; and,
  - v. Adapt products to respond to changing requirements and new market demands.
- This investment will help ensure the resilience of the food system by allowing Canada's fish and seafood processing sector to safely and efficiently process, store, package, and distribute healthy, high-quality products, sourced from our fish harvesters and aquaculture operators, onto the plates of Canadians.
- The Canadian Seafood Stabilization Fund will be delivered through the Atlantic Canada Opportunities Agency, Canada Economic Development for Quebec Regions, and Western Economic Diversification Canada.

**122. July 17th - FedDev Ontario supports women-led businesses to rebuild, reopen and revive in southern Ontario**

- The Government of Canada has announced a **\$4-million FedDev Ontario investment in support of women entrepreneurs across southern Ontario.**
- With this investment through the **Regional Relief and Recovery Fund (RRRF)**, the *Northumberland CFDC* and *WindsorEssex Economic Development Corporation*, in collaboration with regional partners, will deliver the **Rebuild Reopen Revive** Initiative to **support women-led small- and medium-sized enterprises** in rural and urban communities across southern Ontario.
- Both organizations will receive \$2 million to provide **non-repayable contributions of up to \$5,000** to help eligible women-led businesses with key re-opening expenditures, including:
  - Acquisition of reusable personal protective equipment (PPE);
  - Reconfiguration of workspaces to accommodate social distancing impacts; and
  - Enhancing online capacity to improve accessibility and client service.
- Over 700 women-led businesses will be supported through this initiative.

**123. June 23<sup>rd</sup> - Temporary extension of time periods given to employers to recall employees laid off due to the COVID-19 pandemic: Effective June 22<sup>nd</sup>**

- The Government of Canada wants to ensure that as many Canadians as possible have a job to return to and that businesses can grow and stay strong as the economy restarts.
- Today's announcement **extends time periods for temporary layoffs** to allow employers more time to **recall laid-off employees.**
- The temporary changes will help protect the jobs of federally regulated private-sector employees and support employers facing economic hardship as a result of the pandemic.

- Prior to these changes, employers could temporarily lay-off their employees for up to three months if no notice with a recall date was provided, or for a period of up to six months if they provided a notice with an expected recall date, before the lay-off became a termination.
- The amendments, which are set out in the Canada Labour Standards Regulations, **temporarily extend these time periods by up to six months:**
  - i. For employees laid off **prior to March 31, 2020**, the time period is extended by **six months or to December 30, 2020**, whichever occurs first.
  - ii. For employees laid off **between March 31, 2020, and September 30, 2020**, the time period is **extended until December 30, 2020**, unless a later recall date was provided in a written notice at the time of the layoff.
- These changes, which came into effect on **June 22, 2020**, do not apply to employees who are covered by a collective agreement that contains recall rights.
- These changes also do not apply to employees whose employment had already been terminated prior to the coming into force of the amendments.
- The previous rules will apply to layoffs occurring after September 30, 2020.

**125. May 20<sup>th</sup> (Update) - Large Employer Emergency Financing Facility (LEEFF) – Applications Open**

- Purpose: to provide **bridge financing** to **Canada’s largest employers**, whose needs during the pandemic are not being met through conventional financing, in order to keep their operations going.
- The LEEFF program will be open to **large for-profit businesses – with the exception of those in the financial sector** – as well as certain not-for-profit businesses, such as airports, with annual revenues generally in the order of \$300 million or higher.
- To qualify, businesses must be looking for financing of **\$60 million or more** and have significant operations or large numbers of employees in Canada, and must not be involved in any ongoing insolvency proceedings.
- The objective of this support is to help protect Canadian jobs, help Canadian businesses weather the current economic downturn, and avoid bankruptcies of otherwise viable firms where possible.
- This support will **not be used to resolve insolvencies or restructure firms**, nor will it provide financing to companies that otherwise have the capacity to manage through the crisis.
- The government’s support for large employers through LEEFF will be delivered by a subsidiary of the **Canada Development Investment Corporation (CDEV)**, in cooperation with Innovation, Science and Economic Development Canada (ISED) and the Department of Finance.
  - i. Additional information on the application process is available on the [CDEV website](#).
- Further details:
  - i. **Protection of taxpayers and workers:** Companies seeking support must demonstrate how they intend to preserve employment and maintain investment activities.
  - ii. Recipients will need to commit to respect **collective bargaining agreements** and protect workers’ pensions.
  - iii. The LEEFF program will require strict limits to dividends, share buy-backs, and executive pay.
  - iv. In considering a company’s eligibility to assistance under the LEEFF program, an assessment may be made of its

  - vii. The government's support for large companies through LEEFF will be delivered by the Canada Development Investment Corporation (CDEV), in cooperation with Innovation, Science and Economic Development Canada (ISED) and the Department of Finance.

**126. Farm Credit Canada (FCC) Term Loans – Currently Active**

**128. April 27<sup>th</sup> (Update) - 10% Wage Subsidy: Effective Immediately**

- To support businesses that are facing revenue losses and to help prevent lay-offs, the government is proposing to provide eligible employers a temporary wage subsidy for a period of **three months**.
- Those organizations that do not qualify for **the 75% Canada Emergency Wage Subsidy** may continue to qualify for the 10% wage subsidy.
- The **10% Temporary Wage Subsidy** for Employers reduces the amount of income tax source deductions that employers have to remit to CRA on behalf of their employees by **up to 10% of their remuneration** (to a **maximum of \$1,375 per employee up to \$25,000 per employer**).
- Many employers that qualify for the CEWS also qualify for the 10% Temporary Wage Subsidy for Employers.
- CEWS and the 10% Temporary Wage Subsidy for Employers are intended to provide total support of up to 75% for payroll, not 75% + 10%.
- If you did not reduce the source deductions you remitted to the CRA, but you were entitled to the 10% Temporary Wage Subsidy for Employers, the CRA will treat you as having over-remitted your employee source deductions (so that normally you will be entitled to a refund).

- Eligible employers must have an existing business number and payroll program account with the CRA on March 18, 2020; and include:
  - individual (excluding trusts),
  - partnership (see notes in website below),
  - non-profit organization,

- Firms do not need to apply for the subsidy and will be able to benefit immediately from this support by reducing their remittances of income tax withheld on their employees' remuneration.

**129. The Pandemic Response Challenge Program: National Research Council of Canada (NRC) – Currently Active**

**130. March 18<sup>th</sup> - Deferral of Income Tax: Currently Active**

- Allows all businesses to defer, until September 1, 2020, the payment of any income tax amounts that become owing on or after March 18<sup>th</sup> and before September 2020.
- This means you will not be assessed any penalties or interest if your balance due is paid by September 1, 2020.
- The due date for filing
- individual tax returns has been extended to June 1, 2020.
- Taxpayers will have until August 31, 2020 to pay any 2019 income tax amounts owed.
- This relief would apply to tax balances due, as well as instalments, under Part I of the *Income Tax Act*.
- No interest or penalties will accumulate on these amounts during this period. This measure will result in businesses having more money available during this period.

- Employees on a Work-Sharing agreement must agree to a reduced schedule of work and to share the available work over a specified period of time.

**133. March 15<sup>th</sup> - Changes to the Employment Insurance sickness benefits: Currently Active**

- Employment Insurance (EI) sickness benefits provide up to 15 weeks of income replacement and is available to eligible claimants who are unable to work because of illness, injury or quarantine, to allow them time to restore their health and return to work.
- Canadians quarantined can apply for Employment Insurance (EI) sickness benefits.

**Service Canada is ready to support Canadians affected by COVID-19 and placed in quarantine, with the following support actions:**

- The one-week waiting period for [EI sickness benefits](#) will be waived for new claimants who are quarantined so they can be paid for the first week of their claim.
- This temporary measure will be enacted for a minimum of six months.
- Establishing a new dedicated toll-free phone number to support enquiries related to waiving the [EI sickness benefits](#) waiting period
- Priority EI application processing for EI sickness claims for clients under quarantine
- People claiming EI sickness benefits due to quarantine will not have to provide a medical certificate

**135. October 7<sup>th</sup> - New interest relief measure to provide much-needed help to Canada Student Loan borrowers on medical or parental leave**

- The Federal government has highlighted a new measure to help **student borrowers** manage financial burdens they may face when taking **temporary medical or parental leave from their studies**—including for mental health reasons.
- This measure, which was announced as part of Budget 2019, is effective as of **October 1, 2020**.
- Borrowers who are approved under this new measure will benefit from a **suspension of payments and interest on their Canada Student Loans for six months**, which can be extended up to a total of 18 months of leave.

**136. October 2<sup>nd</sup> (UPDATE)- New recovery benefits and extended funding for COVID-19 measures receives Royal Assent**

- The **COVID-19 Response Measures Act** (formerly Bill C-4) has received Royal Assent.
- This legislation **creates three new temporary recovery benefits** to support Canadians who are **unable to work for reasons related to COVID-19**.
  1. Canada Recovery Sickness Benefit (CRSB)
  2. Canada Recovery Caregiving Benefit (CRCB)
  3. Canada Recovery Benefit (CRB)
- These benefits will **be in place for one year beginning September 27, 2020**, as we work to build back a stronger, more resilient economy.
- Canadians will be able to apply through the Canada Revenue Agency (CRA) for the following benefits as of **Monday, October 5:**

- A **Canada Recovery Caregiving Benefit (CRCB)** of \$500 per week for up to 26 weeks per household for workers unable to work for at least 50% of the week because they must care for a child under the age of 12 or family member because schools, day-cares or care facilities are closed due to COVID-19, or because the child or family member is sick and/or required to quarantine or is at high risk of serious health implications because of COVID-19 ; and,
    - A **Canada Recovery Sickness Benefit (CRSB)** of \$500 per week for up to a maximum of two weeks, for workers who are unable to work for at least 50% of the week because they contracted COVID-19, self-isolated for reasons related to COVID-19, or have underlying conditions, are undergoing treatments or have contracted other sicknesses that, in the opinion of a medical practitioner, nurse practitioner, person in authority, government or public health authority, would make them more susceptible to COVID-19.
  - These benefits will be **paid on a weekly basis, meaning Canadians will have to reapply each week they are eligible.**
- **Effective October 12**, the CRA will open the applications for the **Canada Recovery Benefit**, which will provide eligible workers with \$500 per week for up to 26 weeks for those who have **stopped working and who are not eligible for EI**, or **had their employment/self-employment income reduced by at least 50%** due to COVID-19.
  - This benefit will be paid in two-week periods.
- Eligible individuals will be able to apply for recovery benefits online through the **CRA's My Account portal** or by phone through the CRA's automated phone line.
- To get ready to apply for the new recovery benefits, Canadians are encouraged to sign up for the CRA's [My Account](#) to ensure that personal information with the CRA is up-to-date, and to register for direct deposit.

137. September 25<sup>th</sup> - Flexible, more accessible EI system to help support Canadians through the next phase of the recovery
- Eligible Canadians will **transition from the CERB to a flexible and more accessible EI program**, starting **September 27, 2020**, as originally announced on August 20, 2020.
  - Canadians receiving EI are eligible for a taxable benefit at a rate of at least \$500 per week, or \$300 per week for extended parental benefits.
  - Returning to the EI program will allow claimants to benefit from the Working While on Claim rules.
    - These rules allow claimants to keep receiving part of their EI benefits and all their earnings from work.
    - In addition, employers will once again be able to make use of registered Supplemental Unemployment Benefit (SUB) plans to provide support to employees.
  - The EI program will also allow Canadians with **120 hours of insurable work or more to qualify by providing a temporary, one-time credit of 300 insurable hours** for those claiming EI regular and work-sharing benefits.
    - Canadians claiming EI special benefits – including maternity, parental, sickness, compassionate care, and family caregiver – will be provided with a temporary, one-time credit of 480 insurable hours.
  - To ensure a **smooth transition to EI**, the majority of Canadians still receiving the CERB through Service Canada who are eligible for EI will be **automatically transitioned**.
    - Service Canada will contact all EI clients to confirm whether they need to apply or are being transitioned automatically. Clients can also verify the status of their claim in their [My Service Canada Account](#).
  - As is normally the case, Canadians become eligible for their first EI payment at the end of the two weeks that they are out of work.
    - This means, for example, that those switching to EI from CERB effective September 27, 2020, will be eligible for their **first EI payment as of October 11**.

**141. September 3<sup>rd</sup> - The Government of Canada announces over 1,000 new projects in support of seniors impacted by COVID-19**

- The Federal Government has announced over **1,000 new projects** delivered by community organizations across the country to **support seniors during the COVID-19 pandemic.**
- These projects are funded through an investment of **\$20 million** in funding through the **New Horizons for Seniors Program (NHSP).**
- Organizations will receive up to \$25,000 in funding to offer immediate COVID-19 relief or recovery activities to seniors.
- The 2020–21 NHSP community-based Call for Proposals is open until **October 20, 2020.**

**142. August 28<sup>th</sup> - Over 900 new green internship opportunities available for students as Canada builds back better**

- The Government of Canada is partnering with **science, technology, engineering, and mathematics (STEM) employers** across Canada to create **900 internship opportunities** for students through the *Science Horizons Youth Internship Program.*
- Science Horizons supports jobs in clean-technology sectors by offering internships to recent post-secondary graduates in STEM. The program includes specific opportunities for Indigenous graduates, graduates from rural and remote areas, and women in STEM fields. Science Horizons is now open for 2020–21 applications.

- Up to **\$15,000** in Science Horizons funding is available to **employers for each intern they hire**, and interns will receive **experience working on environmental projects lasting six to twelve months**.
- About 90 percent of interns secure a full-time job or return to school after their internship.

**143. August 20<sup>th</sup> - Government of Canada announces plan to help support Canadians through the next phase of the recovery**

- The Federal government has announced **changes to the Employment Insurance (EI) program and new income support benefits** that will better support all Canadians.
  - EI will now be available to more Canadians, including those who would not have qualified for EI in the past, adding more than 400,000 people into the program.
  - Those receiving EI will be eligible for a taxable benefit rate of at least \$400 per week, or \$240 per week for extended parental benefits, and regular benefits will be accessible for a minimum duration of 26 weeks.
  - The government will also **freeze the EI insurance premium rates for two years**, so Canadian workers and businesses will not face immediate increases to costs and payroll deductions due to the additional expenses resulting from the pandemic.
- The government also announced that in preparation for this transition and to ensure support continues for Canadians whose employment has been impacted by the pandemic, the **Canada Emergency Response Benefit (CERB) will be extended by an additional four weeks to a maximum of 28 weeks**.
  - This means that for the many Canadians expecting to exhaust their CERB benefits at the end of August, they will now be able to access an additional month of support.
- Additionally, to ensure Canadians receive the support they need during these challenging times, the Federal government is proposing **three new benefits**:
  - i. The **Canada Recovery Benefit (CRB)** will provide \$400 per week for up to 26 weeks, to workers who are self-employed or are not

eligible for EI and who still require income support and who are available and looking for work. This benefit will support Canadians whose income has dropped or not returned due to COVID-19.

- ii. The **Canada Recovery Sickness Benefit (CRSB)** will provide \$500 per week for up to two weeks, for workers who are sick or must self-isolate for reasons related to COVID-19.
- iii. The **Canada Recovery Caregiving Benefit (CRCB)** will provide \$500 per week for up to 26 weeks per household, for eligible Canadians unable to work because they must care for:
  - a child under age 12 due to the closures of schools or daycares because of COVID-19.
  - a family member with a disability or a dependent because their day program or care facility is closed due to COVID-19.
  - a child, a family member with a disability, or a dependent who is not attending school, daycare, or other care facilities under the advice of a medical professional due to being at high-risk if they contract COVID-19.
- The Government intends to introduce new legislation to support the implementation of the new benefits.

**144. July 27<sup>th</sup> - The Canada Revenue Agency announces an extension to the payment deadline and offers interest relief on outstanding tax debts during the COVID-19 pandemic**

- The Canada Revenue Agency (CRA) is **extending the payment deadline and applying relief to interest on existing debt.**
  - Payment Deadline Extension
    - i. The CRA is extending the payment due date for current year individual, corporate, and trust income tax returns, including instalment payments, from **September 1, 2020**, to **September 30, 2020**.
    - ii. Penalties and interest will **not be charged** if payments are made by the extended deadline of **September 30, 2020**.
    - iii. This includes the late-filing penalty as long as the return is filed by September 30, 2020.
  - Interest on Existing Tax Debt

- i. The CRA is also waiving interest on existing tax debts related to individual, corporate, and trust income tax returns from **April 1, 2020**, to **September 30, 2020** and from **April 1, 2020**, to **June 30, 2020**, for goods and services tax/harmonized sales tax (GST/HST) returns.
  - ii. While this measure for existing tax debts does not cancel penalties and interest already assessed on a taxpayer's account prior to this period, it ensures that a taxpayer's **existing tax debt does not continue to grow** through interest charges during this difficult time.
  - iii. This measure provides **immediate relief** to impacted taxpayers.
- Filing Returns
  - i. The previously extended filing due dates for individual, corporate, and trust income tax returns remain unchanged.
  - ii. However, the CRA will not impose late-filing penalties where a current year individual, corporation, or trust return is filed late provided that it is filed by **September 30, 2020**.
  - iii. To ensure Canadians continue to receive their benefits and credits during the COVID-19 pandemic, the CRA temporarily **suspended interruptions** for those who were unable to file their income tax and benefit return by the **June 1 deadline**.
  - iv. Currently, if a 2019 individual tax return has not been assessed, the CRA is calculating benefits and/or credits for the **July to September 2020** payments based on **information from 2018 tax returns**.
  - v. However, if 2019 individual tax returns are not received and assessed by early **September 2020**, estimated benefits and/or credits will **stop in October 2020** and individuals **may have to repay** the amounts that were issued as of **July 2020**

**145. June 16<sup>th</sup> (Update) - Canada Emergency Response Benefit (CERB):**  
**Applications opened April 6<sup>th</sup>**

June 16<sup>th</sup> Update

- The Federal government is **extending the Canada Emergency Response Benefit (CERB) by eight weeks**, to ensure Canadians have the help they need as they transition back to work.
- This extension will make the benefit available to eligible workers for up to a **total of 24 weeks**.
- Application to the CERB can be **made no later than December 2, 2020**, for payments retroactive to the period of **March 15 to October 3, 2020**.

Original Announcement

- Will provide workers affected by the COVID-19 pandemic with **\$2,000** per month for the next four months. A maximum 16 weeks of benefits can be paid.
- Eligible workers can apply no later than December 2, 2020.
- Applicants who have requested **EI on March 15<sup>th</sup> or later**, won't need to register for the CERB.
- If applying online, with direct deposit requested, applicants can expect the payment **within three to five business days**.
- The CERB payment **cannot** be combined with the 75% wage subsidy for businesses.
- The Benefit is only available to individuals who have stopped work as a result of reasons related to COVID-19. Workers who have not stopped working because of COVID-19, are not eligible for the Benefit.
- Note - Workers who are still employed, but are not receiving income because of disruptions to their work situation due to COVID-19, also qualify for the CERB
- The CERB applies to **wage earners, as well as contract workers and self-employed individuals** who would not otherwise be eligible for Employment Insurance (EI) and are unable to work due to COVID-19.
- The new benefit combines the \$10-billion Emergency Care Benefit and the \$5-billion Emergency Support Benefit that were announced earlier.
- *Some examples workers eligible for the CERB include:*
  - I. Workers, including those who are self-employed, who must stop working due to COVID-19 and do not have access to paid leave or other income support;

- II. Workers who lost their employment, as well as workers who are sick, quarantined or taking care of someone who is sick with COVID-19;
- III. Working parents who must stay home without pay to care for children that are sick or need additional care because of school and daycare closures; and
- IV. Workers who still have their employment but are not being paid because there is currently not sufficient work and their employer has asked them not to come to work.

The CERB is available to workers who meet all of the **following conditions**:

- Live in Canada and are at least 15 years old
- Have stopped working because of reasons related to COVID-19, or are eligible for EI regular or sickness benefits, or have exhausted their EI regular or fishing benefits between December 29, 2019 and October 3, 2020
- Had employment and/or self-employment income of at least \$5,000 in 2019, or in the 12 months prior to the date of their application
- Have not earned more than \$1,000 in employment and/or self-employment income per benefit period while collecting the CERB
- Have not quit their job voluntarily

To help more Canadians benefit from the CERB, **the government is announcing changes to the eligibility rules** to:

- Allow people to earn up to \$1,000 per month while collecting the CERB.
- Extend the CERB to seasonal workers who have exhausted their EI regular benefits and are unable to undertake their regular seasonal work as a result of the COVID-19 outbreak.
- Extend the CERB to workers who have recently exhausted their EI regular benefits and are unable to find a job or return to work because of COVID-19.

These changes will be retroactive to March 15, 2020.

**146. May 15<sup>th</sup> (Update) - Extension of Tax Filing Deadline and Benefit Payment**

**Dates: Currently Active**

- The tax filing deadline for individuals has been extended to June 1, 2020, and allows all taxpayers to defer, until after August 31, 2020, the payment of any income tax amounts that become owing on or after March 18<sup>th</sup> and before September 2020.
- This relief would apply to tax balances due, as well as instalments, under Part I of the *Income Tax Act*.
- The deadline to pay any balance due for your individual income tax and benefit return for 2019 has been extended from April 30, 2020, to September 1, 2020.
- This means you will not be assessed any penalties or interest if your balance due is paid by September 1, 2020.
- **May 15<sup>th</sup> Update** - Benefit payments will continue for an additional **three months** for those who are not able to file their 2019 returns on time.
  - i. Eligible Canadians who are presently receiving the **Goods and Services Tax/Harmonized Sales Tax (GST/HST) credit** and/or the **Canada child benefit (CCB)** will continue to receive these payments until the end of September 2020.
  - ii. If 2019 tax returns are not received and assessed by **early September 2020**, estimated benefits and/or credits will stop in October 2020 and the taxpayer will have to repay the estimated amounts that were issued as of July 2020.

**147. March 18<sup>th</sup> - Registered Retirement Income Funds (RRIFs) – Minimum Withdrawals**

- The reduction of minimum withdrawals from Registered Retirement Income Funds (RRIFs) by **25 per cent for 2020** in recognition of volatile market conditions and their impact on many seniors' retirement savings.

**148. March 18<sup>th</sup> - Deferral of Canada Student Loan Payments: **Implementation by Early April****

- The implementation a **six-month, interest-free**, moratorium on Canada Student Loan payments for all individuals who are in the process of repaying these loans.
